Grantee Profile: As of March 30, 2010 the number of subcontractors was reduced to 3. As of March 30, 2010 one county health department site was added.

Table 1: The reduction in numbers served was primarily related to the county health department system where delays have been experienced in refilling staff positions (e.g., nursing and clerical) due to deficits in the State budget.

The Tulsa Health Dept. offers Implanon and female condoms. Zero values in cells are intended.
