- **Oklahoma State Department of Health Budget:**

Mark Newman, Director State Federal Policy

- All state agencies are being affected by budget situation.
- OSDH will receive at least a 10% cut over 6 million dollars on future years.
- We have had a 4.2% cut.
- Some agencies will receive a 20% cut.
- OSDH is 60% federally funded and less than 15% state funded.
- Next year could continue to get worse, not expected to improve any time soon.
