



# Mosquito Repellent

## How does mosquito repellent work?

Mosquitoes are attracted to people by skin odors and carbon dioxide from breath. Repellents contain an active ingredient which repels mosquitoes, making the person unattractive for feeding. It does not kill mosquitoes; it just makes them unable to locate us. Repellents are effective only at short distances from the treated surface, so you may still see mosquitoes flying nearby. As long as you are not getting bitten, there is no reason to apply more. A higher percentage of active ingredient in a repellent does not mean that your protection is better—just that it protects you from mosquito bites for a longer period of time.

## What are effective active ingredients in mosquito repellent?

- ◆ **DEET**: Considered one of the most effective repellents. DEET-containing repellents offer the longest mosquito protection time compared to all other mosquito repellents. Common brand name examples include: Off!, Cutter, Sawyer, and Ultrathon.
- ◆ **Picaridin**: Also considered one of the most effective repellents. Common brand name examples include: Cutter Advanced, Skin So Soft Bug Guard Plus, and Autan (outside the United States).
- ◆ **Oil of lemon eucalyptus (OLE)**: A plant-based repellent which has been shown to have similar protection to lower concentrations of DEET. This product cannot be used on children less than three years of age.
- ◆ **IR3535**: A newer repellent recently approved that has shown to be an effective active ingredient. Common brand name examples include: Skin So Soft Bug Guard Plus Expedition and SkinSmart.

## How should you choose a mosquito repellent?

Consider the following when choosing a repellent:

- ◆ How long you will be outdoors
- ◆ Time of day
- ◆ Temperature
- ◆ Type of activity that you will be doing
- ◆ Location



Repellents offer protection for a limited time. In general you should re-apply repellent if you are being bitten by mosquitoes. Mosquitoes are most active in the early morning when the sun rises and in the late evening when the sun sets. Sweat or water wash repellent off, so if you will be working outdoors or swimming, it may be necessary to re-apply repellent more often.

## How do I stay safe when using mosquito repellents?

- ◆ Never use repellents over cuts or wounds on your skin.
- ◆ Only apply to exposed skin; do not apply repellents under your clothing.
- ◆ You only need to use enough repellent to cover exposed skin. Heavy application will not give you better or longer lasting protection.
- ◆ Do not spray directly on your face. Spray on your hands first and then apply to your face.

## What products contain approved active ingredients?

There are many products available that provide protection against mosquito bites. The following table offers different options based on the length of time that they offer protection.

### What is permethrin?

- ◆ A repellent and insecticide that can treat items like pants, socks, boots, backpacks, tents, and other gear. Permethrin-treated products repel mosquitoes and also kill ticks.
- ◆ Do not apply permethrin-containing products directly to the skin.

### Can mosquito repellents be used on children?

- ◆ Yes, DEET products can be used on children older than 2 months of age.
- ◆ Protect infants by using a mosquito net draped over a carrier.
- ◆ Oil of lemon eucalyptus should not be used on children under the age of three years.
- ◆ Do not allow children to handle or spray the product. Apply repellent to your own hands first and then put it on the child. Avoid applying repellent to children's hands because children frequently put their hands in their eyes and mouths.
- ◆ EPA does not recommend any additional precautions for using registered repellents on children other than those listed above.

### Is it safe to use mosquito repellent during pregnancy or while breastfeeding?

- ◆ Yes, EPA-registered repellents are safe for use in both pregnant and breastfeeding mothers.
