Changes for Out-of-State Transports

The Office of the Chief Medical Examiner (OCME) and the Oklahoma State Department of Health (OSDH) has received a State's Attorney General opinion which will require some changes to the process associated with the investigations and permits for the transportation of bodies out of state. (AG Opinion 2011-21)

OCME is required to investigate the "death of person whose bodies are to be cremated, buried at sea, transported out of the state, or otherwise made ultimately unavailable for pathological study." (63 OS 938B). The Chief Medical Examiner is authorized to receive compensation for such services and the fee for the investigation of out-of-state transports is \$100. [OAC 445:10-11(2)(D)(iii)]

If the body is to be transported by common carrier within Oklahoma or to any point outside of the state, the burial-transit permit should be obtained from the State Registrar. "No railroad or other common carrier shall

receive for shipment to any point within the state or to any point outside the state the body of a deceased person unless there is attached to the shipping case, in a strong envelope, a burial-transit permit duly issued and signed by the local registrar of the district in which the death occurred or the body was found." (63 OS 101)

The resulting new process took effect January 1, 2012:

- On Tab 10 in ROVER, funeral home selects "Refer to ME for Transport Permit" from the drop down.
- Funeral home faxes the worksheet to OCME.
- OCME grants the permit and faxes the "Release of Jurisdiction for Out of State Transport" to funeral home.
- Funeral home faxes the "Release of Jurisdiction for Out of State Transport" with the Medical Examiner's signature to OSDH at 405.271.2899.
- OSDH faxes the "Transportation by Common Carrier

Application" to the funeral home.

- Funeral home completes the "Transportation by Common Carrier Application" and faxes it back to OSDH at 405.271.2899.
- OSDH Vital Records reviews the Application and then faxes to the funeral home the "Release of Jurisdiction for Out of State Transport" with the State Registrar's signature added to the bottom.
- Attach the completed permit to the shipping case.

Possible Scam Alert for Social Security Numbers


A funeral home recently told us that they received a suspicious phone call from an unidentified person claiming to be with the local Social Security Office. The caller asked if the funeral home was using ROVER to register death certificates. The funeral home employee said “yes.” The caller then said that the Social Security verification had failed for a particular decedent and that she needed to verify the number.

The funeral home employee felt uncomfortable with this request. She said she would have to retrieve that information and asked for a phone number for a return call. The caller then

said “oh, that’s okay” and hung up. It should be noted that the caller did not offer a Social Security Number to be verified.

We called the Social Security Administration in Oklahoma City to discuss this incident. They confirmed that this appeared to be a phishing incident. If they contact a funeral home about a death report, they would have specific information to be confirmed. They would give a name and number for a return call or confirmation. Any information they need could be faxed to them. There is NEVER a reason to give Social Security Numbers over the phone to someone you cannot identify.
