

# **List of non-qualifying communities to fulfill a PMTC obligation**

PMTC defines "rural" as any community 25 miles or more from the OKC and Tulsa metro areas. This page lists the communities that do not meet this definition, and **do not qualify** to fulfill a PMTC obligation. Please review this list carefully, as it may include some communities that you would otherwise consider to be rural. If you are uncertain as to whether or not the facility you plan to fulfill at is considered rural, please don't hesitate to ask so that we can make sure.
