

## **RULE IMPACT STATEMENT**

### **TITLE 540. HEALTH CARE WORKFORCE TRAINING COMMISSION CHAPTER 25. PHYSICIAN AND HEALTH MANPOWER PLACEMENT SERVICES**

#### **A. BRIEF DESCRIPTION OF PURPOSE OF PROPOSED RULES:**

The Health Care Workforce Training Commission proposes changes to its rules to comply with recently-enacted H.B. 2776, 58th Leg, 2d Reg. Sess. (Okla. 2022), which changed the composition of the Commission as well as the agency's name. The Commission also proposes changes to fix scrivener's errors and clean-up the language, more generally.

The proposed changes for Chapter 25 do not have a fiscal impact to the agency and are an effort to bring rules in compliance with statute.
