TITLE 540. HEALTH CARE WORKFORCE TRAINING COMMISSION CHAPTER 50. OKLAHOMA MEDICAL LOAN REPAYMENT PROGRAM

A. BRIEF DESCRIPTION OF PURPOSE OF PROPOSED RULES:

The Health Care Workforce Training Commission proposes revising its rules relating to the Medical Loan Repayment Program. These rule changes will make the rules comply with current statute. Recent statutory changes expanded the scope of the program to include certified nurse practitioners and to apply to general surgery. (H.B. 1696, 59th Leg., 2d Reg. Sess. (Okla. 2024), codified at 63 O.S., §§ 1-2721 and 1-2722).

The proposed changes will affect program participants and benefit a greater segment of rural communities through the Medical Loan Repayment Program.

C. CLASS OF PERSON(S) BENEFITED BY PROPOSED RULES:

The proposed changes will benefit certified nurse practitioners and rural communities seeking assistance through the Nursing Loan Repayment Program. The proposed changes will also benefit physician participants specializing in general surgery and rural communities seeking assistance through the Physician Loan Repayment Program.

There will be no financial impact because of these rule changes. The proposed changes are to align HWTC programs, providing consistent practices in aiding in recruiting providers across rural Oklahoma, and meeting the changes in demand for rural providers.
