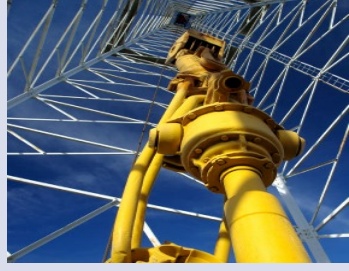
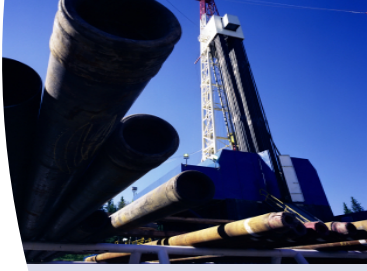

2016

- ERRT surveyed state O&G regulators and found that to respond proactively to changing technologies and practices, regulators needed ready access to tip-of-spear information from technical societies and leading experts

2018

- ERRT began a process of collecting key topics of concern from regulators and sharing them with technical societies for feedback

2019

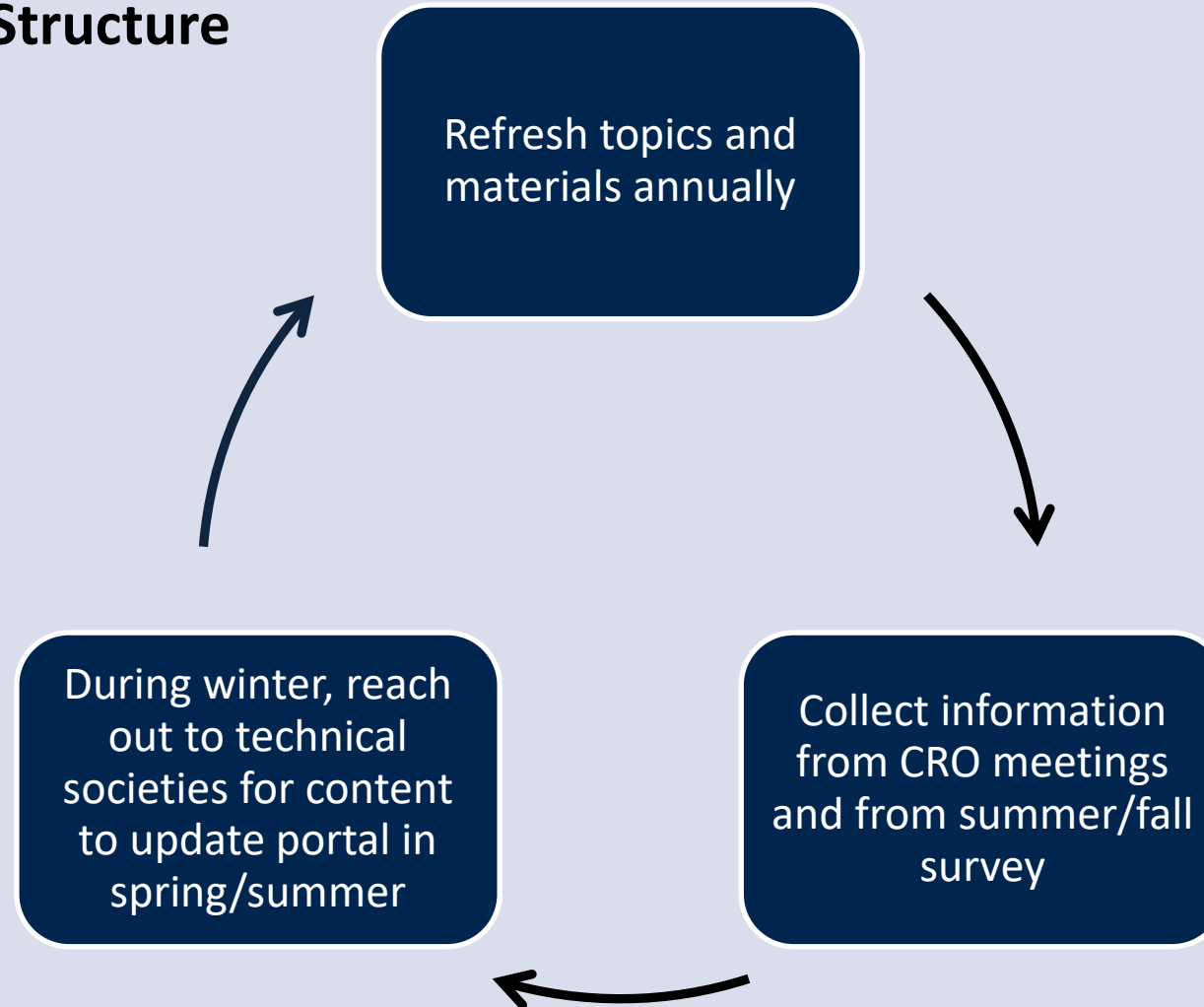
- ERRT launched a regulator-only portal on IOGCC's website to compile and share this information

2020

- The regulator-only portal is continually updated with material from technical societies while 2019 material is archived, and webinars have been held with more planned

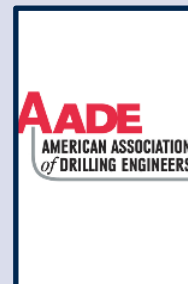



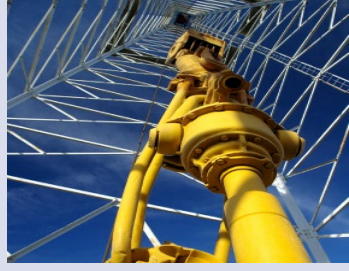
