In the northwest sector inspections were held in Oklahoma City, Mustang and Elk City and reinspection's at Oklahoma City, Watonga, and Kingfisher. The new station for ONG Woodward has been approved for subterranean utilities. The repositioned Section V!!! vessels at ONG North Santa Fe have been inspected and certified. Participation in the NIST TGT Power collaboration had positive results. They have approved the first phase of Bedrock venture. There is a pending hydrogen project in Catoosa that needs approval of their storage/transit pods that will be scheduled.
