Some of the other activities include working with an engineer from Norway on the Woodside Ardmore H2 project and joined in a Teams call with DEQ on an H2 activity update to include Woodside Ardmore and Tinker AFB.

David Frick, Air Quality and Clean Cities Planner II, reported on federal funds and grants available for alternative fuels. The first round of the grant has past, and the second round will be happening soon. There is a partnership available that is wanting to put alternative fuels stations in disadvantaged communities. If you know of any private companies that would like to embark, please let David know. The first round included \$700 million across the nation. Other grant projects include electric vehicles, and one community requested a compressor to help keep their public busses. ODOT has \$66 million for level three (3) charging. The groups that are applying are the large travel stops across the state.
