



Class X (10) Permit Application

Permits the holder to actively manage LPGas operations or a branch of a Class 1 permit holder. **Exam Fee: \$55.00 (submit with application).** This application shall be on file in the office of the administrator at least 30 days prior to testing. Testing is in January, April, July, October.

Exam Fee: \$55.00 (submit with application) This application shall be received in the Administrator's office 30 days prior to testing. Testing dates are in January, April, July, and October. Call the office for the exact dates, time, and location.

Permit Fee is \$150.00 plus a \$10.00 filing fee once the applicant passes the test. There will be 100 test questions, taken from material in the current versions of NFPA 54 & 58 and the Oklahoma LP Gas Rules. Passing score is 80% or above.

____ I agree to submit plans and drawings on the required storage containers, dispensers, and public buildings to the Oklahoma LP Gas Administration for approval before the installation of them.

____ I agree to furnish Form 4's and other approved forms to the Oklahoma LP Gas Administration on all installations of LP gas systems or appliances and on any new customers we have not serviced in the last 24 months.

____ I understand that this permit does not allow the holder to install or service LP gas alternative fuel systems (carburetion).

____ I understand that this permit will expire on August 31st each year. If renewed after this date, I understand there will be an additional 25% late fee assessed.

____ I understand that no permit will be renewed after September 30th, without the approval of the LP Gas Administrator.

____ I certify that this information is true and correct. Any false or fraudulent statement for failure to comply with the rules and regulations promulgated by the Liquified Petroleum Gas Board or Oklahoma Statutes Title 52, Chapter 8, Section 420.1 through 420.15 shall be cause for suspension or revocation of the permit held.

From LP Gas Rules and Regulations 420:10-1-5 (D)

11) Class X - Manager's Permit.

(A) A Class X Manager's permit is required for a person actively in charge of LP Gas operation for holder of Class I permit and at each separate branch or base of operation of a Class I permit. All Class X holders must be a full-time employee of said Class I holder. The annual fee for a Class X permit is One Hundred Fifty Dollars (\$150.00).

(B) Before testing for a Class X permit, an applicant must meet the following requirements as approved by the Board:

(i) Hold an active Class IV or Class IV-D permit and employed under an active Class I Dealer for a minimum of three (3) years or equivalent; and

(ii) One (1) year of the minimum three (3) years required experience can be satisfied with forty (40) hours of specified training.

(C) Temporary exemptions for emergency conditions can be granted by the Administrator.

To elaborate on specified training used as an exemption for 1 year's employment:

The rules look to management experience for safety reasons and has approved such training as extensive CETP hours, other states LP training courses such as the 40 hour school held by the Arkansas LP Gas Board, the 80 hour school held by the Texas Railroad Commission and other states training courses and our 20 hour training for the testing school.
