

# Food Truck Permit Application and Attestation

A \$10.00 filing fee must be submitted with this Food Truck Permit Application and Attestation.

A Food Truck is defined as any vehicle or movable unit, including self-propelled food trucks, towable food trailers, or other portable structures, equipped with cooking appliances that produce smoke or grease-laden vapors, or that utilize, handle, or transport liquefied petroleum gas (propane), or contain any liquefied petroleum gas system, equipment, container, apparatus, or appliance.

A Food Truck must maintain a valid permit and undergo an annual inspection conducted by the Oklahoma Liquefied Petroleum Gas Administration. A separate Food Truck Permit is required for each individual Food Truck, even if multiple units are owned by the same business.

I attest that I am familiar with all applicable requirements set forth in Title 52, Section 420 et seq. of the *Oklahoma Liquefied Petroleum Gas Act*, Title 420 of the *Oklahoma Administrative Code (OAC)*, and *NFPA 58*, including Chapter 16 (Mobile Food Preparation Vehicles), and that I will comply with all such requirements.

I attest that the liquefied petroleum gas systems, equipment, containers, apparatuses, and appliances on my commercial or retail mobile food preparation vehicle meet all applicable requirements of Title 52, Section 420 et seq. of the *Oklahoma Liquefied Petroleum Gas Act*, Title 420 of the *Oklahoma Administrative Code (OAC)*, and *NFPA 58*, including Chapter 16 (Mobile Food Preparation Vehicles).

I understand that this permit is non-transferable and applies only to the business and food truck identified herein. Any change in the food truck, business name, or ownership must be reported to the Oklahoma LP Gas Administration immediately.

I understand that if any accident or fire involving propane occurs on this food truck, the Oklahoma LP Gas Administration will be notified as soon as feasibly possible, but no later than 2 business days via email: [lpgasinfo@lpgas.ok.gov](mailto:lpgasinfo@lpgas.ok.gov) or via phone at (405) 521-2458.

I understand that this permit will expire on October 31st each year. If renewed after that date, a 25% late fee will be assessed. I further understand that the permit may be renewed as early as September 1st each year.

I understand that no permit will be renewed after November 30th of each year, and that I will be required to submit a new application if renewal is not completed by that date.

I understand that the food truck identified by VIN and/or License Plate Number herein must undergo an annual inspection by November 1, 2026, and by November 1 each year thereafter. I agree to present the identified food truck for inspection at one of the scheduled inspection events listed on the LP Gas Administration's website: <https://oklahoma.gov/lpgas/food-trucks.html>.

I certify that all information provided is true and correct. Any false or fraudulent statement, or failure to comply with the applicable requirements of Title 52, Section 420 et seq. of the *Oklahoma Liquefied Petroleum Gas Act*, Title 420 of the *Oklahoma Administrative Code (OAC)*, or *NFPA 58*, including Chapter 16 (Mobile Food Preparation Vehicles), may result in the suspension or revocation of this permit.
