Terri Lowery, Director, Mary Allen Carey, Ph.D., R.N., Interim Director of Nursing Education, and Rebecca Cornelius, MSN, RN, Director of Nursing Education, were present to address questions of the Board.

The Board raised concerns regarding the high rate of turnover of nurse administrators in the program, with three different individuals serving as the nursing administrator for five different periods in the past 28 months. In addition, the Board identified there has been a high faculty turnover and it was noted that the program had failed in most cases to timely inform the Board of changes in staff and timely provide faculty credentials to the Board. At the time of the hearing, the longest serving staff member had been with the program for seven months. Board members noted that this may result in inconsistent instruction and an inappropriately high student to faculty ratio during times in which positions are vacant. The Board also expressed concern regarding inconsistent implementation of grading and student evaluation policies and with the Campus Director inserting herself into the nursing program in inappropriate ways, as Board Rules require that nursing instruction be provided by nurses, and not by administrators who do not themselves have any nursing education.

The Board further expressed concern that the situation prevailing at the ITT nursing program for at least one and a half years provided no consistency for the students.

Based on these concerns, it was moved (J. Cash) and seconded to change the program's approval status for ITT Technical Institute, Oklahoma City, to "Conditional" for a period of one year, to provide the program with an opportunity to correct the deficiencies listed in OAC §485:10-5-3.2 (b), (1) (d) (1); OAC §485:10-5-4.1 (f) (g); OAC §485:10-5-5 (a) (1); and OAC §485:10-5-5.2 (a), (e) (3).
