The implementation date must occur within 6 months of the effective date. Rule committees for development of language will be organized at Delegate Assembly. Following activities occurring at Delegate Assembly, letters will be sent to licensees in every state adopting the eNLC with NCSBN handling the mailings. Other groups receiving letters will be nursing education Deans and Directors and nursing employers. After Delegate Assembly concludes, OBN will launch the eNLC information on the agency's website. The agency is still on target to enter Nursys by October 1, 2017.

The agency's rules adopted by the Board at its January meeting will be considered promulgated and effective on August 25th. New rule books will be distributed to Board Members at the September Board meeting. K. Glazier also reported on Interim Studies the agency is tracking.
