Director Barnhouse reported the agency's FTE Status (number of full-time equivalent employees) as 27 with the number increasing to 28 FTEs as of December 1st. The law change also authorizes the OTC to garnish the wages of the licensee to collect any delinquent taxes, penalties, and interest owed.
