 - 3.1 **Proposed Permanent** *Rules*: J. Ward summarized proposed changes to the Oklahoma Board of Nursing Rules. Subchapter 5 – new language recognizing the privilege to practice in OK off of a MSL from another compact party state; Subchapter 7 – adding another option for foreign credential evaluation for applicants educated in another country and adding another option for English language test for competence in oral and written English; Subchapter 11: new language clarifying the 20-day timeline of sending written orders to licensees and applicants following review of Board Orders by the Attorney General's office; amended language regarding Board orders following disciplinary action, felony convictions as they relate to the licensure of individuals with a criminal history, and Subchapter 18 – Certified Registered Nurse Anesthetist (CRNA) initial application criteria clarifying the options of meeting the pharmacology requirements for CRNA renewal.
 - 3.2 Approved Emergency Rules, Subchapter 23: J. Ward summarized the proposed emergency rule revisions in OAC 485:10-5-4.1 which provides an option for Board-approved nursing education programs with at least 600 total program clinical hours to provide 50% simulated patient care experiences, provided at least one instructor in the nursing education program be simulation certified. The emergency rules were approved by Governor Stitt on March 10, 2023. The expiration date of the approved emergency rules is September 14, 2024.
 - 3.3 No business
 - 3.4 **CRNA Reminder Specific to Legend Drugs:** J. Ward provided updates regarding SB0458, HB1005, HB1709, HB1650, SB0132, SB0613, and SB0665.
 - Prescribing changes for Buprenorphine: M. Edwards provided an 3.5 update regarding DEA changes to requirements for prescribing Buprenorphine. DEA DATA waiver and X DEA numbers are no longer required for prescribers. There is no longer a limit on the number of patients a prescriber can treat with Buprenorphine. New training will be required with the effective date June 27, 2023. The DEA will provide information regarding the education at a later date.
