3.0 Board Update (verbal reports only, requiring no action by Committee):

3.1 Proposed Permanent Rules: J. Ward summarized proposed changes to the *Oklahoma Board of Nursing Rules*. Changes include language clarifying the requirement to notify the Board of a name or address change within 30 days.

3.2 Approved Emergency Rules, Subchapter 23: J. Ward summarized the Emergency the *Rules* which allow for temporary nursing licenses to be provided to nurses without providing continuing qualifications and out of state nurses who are in good standing with their state Board. These temporary licenses will expire September 14, 2022.

3.3 CRNA Reminder Specific to Legend Drugs: J. Ward provided a summary of the email message sent to Oklahoma CRNAs specific to Legend Drugs.

3.4 Legislative Update: J. Ward provided an update regarding House Bill 3319 and House Bill 3892.

3.5 CRNA Formulary Advisory Council membership: G. Stafford reported the appointment term for Victor Long expired and the Oklahoma Association of Nurse Anesthetists appointed Jenny Schmitt to serve on the Council. Dr. B. Seacat will complete his term before the next meeting. The Oklahoma Society of Anesthesiologists will be contacted for a reappointment or a new appointment.

3.6 Other: no other reports

4.0 Review and committee recommendations on revisions to CRNA Inclusionary Formulary: Council members reviewed the DRAFT *CRNA Inclusionary Formulary*, #P-50A with proposed revisions. A list of new and updated drug classifications was provided to committee members. After discussion, it was moved (B. Kennedy) and seconded to recommend the following revisions to the *CRNA Inclusionary Formulary*, #P-50A and forward to the Board for approval. The proposed revisions are listed below:

- Remove three drugs
 - Chlorpropamide-discontinued
 - Urea 40 50%-discontinued
 - Sodium Chloride 20%-not used

- Remove “Not in AHFS” and “PO or IV” throughout the DRAFT, with the exception of Blood and Blood Components
- Replace the word “Agents” with the correct word “Agonist”
- Remove the word “intravenous” and change the sentence to match the other directives in the DRAFT, “all in this class approved including future new drugs”
- Add an “s” to the word “Anti-Infective”
- Language clarification addressing ACLS medications
- Update the reference for *AHFS Drug Information* to the current edition (2022)
