- Call to order. J. Ward called the meeting to order at 1:00 p.m.
   Declaration of a quorum: A quorum of members was present as determined by roll call.

## 3. Verbal reports requiring no action by committee.

- 3.1. **Proposed** *Oklahoma Board of Nursing Rules*: J. Ward summarized the proposed changes to the Rules pursuant to Executive Order 2020-03. The omnibus joint resolution approving this year's proposed permanent rules was passed by the Legislature and sent to the Governor on May 26, 2021.
- 3.2. **Optimal Regulatory Board System (ORBS) Licensing Data Base**: J. Ward shared that T. Walker will be working with the nursing education program directors regarding the Affidavit of Graduation portal to be piloted this fall.
- 3.3. **Executive Orders related to COVID-19**: J. Ward provided an overview of Executive Orders filed since March 12, 2020 when Governor Stitt urged Oklahoma to be ready for the threat of COVID-19. Pursuant to the most recent Executive Order, Executive Order 2021-11, effective May 4, 2021, Second Amended Executive Order 2021-07 was withdrawn and rescinded. Governor Still rescinded the declared emergency caused by the threat of COVID-19 to the people of the State of Oklahoma.
- 3.4. **National Council of State Boards of Nursing Annual Report Template**: T. Walker provided and update that report template will be provided to the Board-approved nursing education programs on July 1, 2021 with direction to the nursing education programs that the report template is to be completed and returned to NCSNB by August 1, 2021. In addition, nursing education administration will also submit to the Board of Nursing clinical and faculty summaries.

- 3.5. **Expiration of terms for committee members**: J. Ward reported the upcoming terms to expire are Liz Michael and Kim Stout, both representatives of the Oklahoma Organization of Nurse Executives (OONE) and both expiring on October 31, 2021. Ms. Ward will contact OONE to make them aware.
- 3.6. **Board of Nursing Guidelines**: G. Stafford and T. Walker presented changes to the following guidelines.

- 4. **Review and committee recommendation on request for revisions to** *Simulated Patient Care Experience (SPCE) for Registered and Practical Nursing Programs Guidelines, #E-11.* T. Walker and J. Ward reviewed the position statement with committee members. T. Walker presented changes in updated references. Dr. Julie Hoff then presented her request to amend III. KK. 9 to allow 10% virtual computer-based simulations of the 30% of allowable SPCE. Next, Dr. Casey Cassidy presented a summary of articles provided with the meeting packets and requested consideration of an amendment to allow nursing education programs to have one hour of SPCE to equal two hours of clinical learning experiences in the clinical setting. After discussion, committee members made two separate motions. The first motion was made (S. Hovis) and seconded that III.KK.9 be amended to "Virtual computer-based simulations provided through algorithms and predefined patient findings may be used up to 10% of the 30% allowable SPCE". J. Ward stated that the proposal for change would be presented for legal review prior to moving the recommendation forward for Board approval.

7. Discussion of *Employment of Nursing Students or Non-Licensed Graduates Guidelines*, **#E-04.** J. Ward presented the history of the guideline to committee members sharing that the guideline was first developed in 1990 when Graduate Nurses were removed from law. The guideline is a prelicensure, education guideline. The guideline was last presented to the Nursing Education and Nursing Practice Advisory Committee during the February 2020 meeting; and, at that time, it was decided by the committee for Board staff to collect additional information regarding the guideline and place it on a future committee agenda for discussion. The guideline was a part of the pandemic emergency rules, which continued until May 4, 2021, and was therefore unable to place on a committee for further review until the June 11, 2021 regularly scheduled meeting. discussion of the guideline, a majority of the committee members (10) requested no changes to the guideline. J. Ward stated that the discussion will be provided for legal counsel review and guidance.

Recommendations from the subcommittee will be presented at a future Nursing Education and Nursing Practice Advisory Committee meeting.
