# 3. Verbal reports requiring no action by committee:

- 3.1. Changes to the Oklahoma Nursing Practice Act: J. Ward shared that HB 2482, proposed changes to the Oklahoma Nursing Practice Act, was signed by the Governor and will be effective November 1, 2016. Ms. Ward reviewed the changes with the committee.
- 3.2. Changes to the *Rules* of the Oklahoma Board of Nursing: J. Ward reported that the Governor had signed the declaration of approval/disapproval of this year's proposed permanent rules. The Board of Nursing proposed permanent Rules which were adopted and submitted to the Governor and Legislature prior to April 1, 2015, were considered approved and adopted. Ms. Ward reviewed the changes that became effective August 25, 2016.
- 3.3. Summary of impact of Rules on Nursing Education Programs, effective August 25, 2016. Ms. Walker reviewed the impact of *Rules changes* (effective August 25, 2016) on the regulation of nursing education programs as Ms. Ward introduced the changes.
