- 3.1 **Changes to the** *Rules* **of the Oklahoma Board of Nursing:** J. Ward reviewed proposed changes to the *Oklahoma Board of Nursing Rules* to be presented to the Board of Nursing during the November 2017 Board meeting for Board member input. A public hearing and vote of the Board will be scheduled for the March 2018 Board meeting.
- 3.2 **Nurse Population Statistical Information from FY 2017 Annual Report:** J. Ward provided the link to the FY 2017 nurse population statistical report and reviewed the licensure count by type for FY 2017, including Registered Nurses (RNs), Licensed Practical Nurses (LPNs), Advanced Practice Registered Nurses, APRNs with Prescriptive Authority, and Advanced Unlicensed Assistants.
- 3.3 **Update on enhanced Nurse Licensure Compact:** J. Ward provided an update on the enhanced Nurse Licensure Compact (eNLC) reporting that 26 states have passed the eNLC legislation; the eNLC was effective on July 20, 2017 and will be implemented on January 19, 2018. Ms. Ward provided a review of information available through the eNLC link on the Board of Nursing website to include a summary of the implementation of the eNLC; the Notice of Public Hearing on eNLC Proposed Rules; the difference between effective date and implementation date; fact sheets for both faculty and students, and licensed Registered Nurses and Licensed Practical Nurses; implementation frequently asked questions; uniform licensure requirements for an eNLC multistate license; and the link to the National Council of State Boards of Nursing website.
- 3.4 **Board appointment of Advanced Practice Registered Nursing Education representatives to the Advanced Practice Advisory Committee:** G. Stafford reported appointments made by the Board of Nursing, during the July 2017 Board Meeting, to the Advanced Practice Advisory Committee to include Gina Crawford, DNP, APRN-CNP, as a representative of Oklahoma Certified Nurse Practitioner nursing education program faculty and Melissa Craft, PhD, APRN-CNS, as a representative of Oklahoma Clinical Nurse Specialist nursing education program faculty.
