<u>Agenda Item #3 – Public Comment Period</u>: Executive Director Ross advised the Board that he had not received any requests for public comment.

Agenda Item #– Consent Agenda: The Consent Agenda contained four items for the OAB's consideration: (1) Approve the Minutes of the February 19, 2021, Regular Meeting of the OAB; (2) Take official notice of the preliminary OAB financial statements for month ending February 28, 2021, and March 31, 2021; (3) Take official notice of the experience verification applications which have been approved by the Executive Director; and (4) Approve the actions taken by the Executive Director on applications and registrations filed since the previous meeting.

Agenda Item #5 – Discussion and possible action on Administrative Actions and recommendations and report from the Enforcement Committee:

ADMINISTRATIVE CONSENT ORDER:

<u>Case No. 2252 – CPA</u>

This case was opened as a result of a referral by the CPE Coordinator that Respondent was 4 hours short of meeting the four-hour minimum ethics CPE requirement for compliance period 2017-2019. An Administrative Consent Order was offered by the Enforcement Committee and accepted by the Respondent whereby Respondent is assessed a fine of \$500, plus costs and attorney fees in the amount of \$241.90, which must be paid within 30 days of the effective date of the order. Respondent has already submitted 4 hours of ethics to apply to the shortage. A proven violation of this ACO, the Act or the Board's Rules authorizes the Board to take such other and further action as the Board may deem appropriate under the Act. The Enforcement Committee recommends the Administrative Consent Order in this case be approved by the Board.

<u>Case No. 2254 – CPA</u>

This case was opened as a result of a referral by the CPE Coordinator that Respondent was 19 hours short of meeting the 120-hour minimum CPE requirement for compliance period 2016-2018, and 38 hours short for compliance period 2017-2019. An Administrative Consent Order was offered by the Enforcement Committee and accepted by the Respondent whereby Respondent is assessed a fine of \$1,000, plus costs and attorney fees in the amount of \$294.40, which must be paid within 30 days of the effective date of the order. In addition, Respondent must submit 38 hours of CPE to apply to the shortage. A proven violation of this ACO, the Act or the Board's Rules authorizes the Board to take such other and further action as the Board may deem appropriate under the Act. The Enforcement Committee recommends the Administrative Consent Order in this case be approved by the Board.

This file was opened as a result of a submitted complaint alleging the registrant failed to deliver a timely audit and would not return the complainant's attempted communications. The registrant also failed to respond to the Board's inquiry and allowed registrant's CPA certificate to automatically revoke due to failure to register earlier this year. Therefore, the Enforcement Committee recommends that the file be closed with a not to reopen the investigation if registrant applies for reinstatement.
