

Pursuant to 10:15-37-11 of the Oklahoma Administrative Code, the following crimes, as set out in Title 21 and Title 63 of the Oklahoma Statutes, shall disqualify an individual from obtaining or holding an Oklahoma CPA certificate or PA license. In addition, "disqualifying crimes" shall be deemed to include crimes under any federal law, state law, or valid town, city or county ordinance, that are substantially similar to those identified on this list. Expunged criminal history does not require disclosure and is not deemed disqualifying.
