



Impacts of Airport Management

- Obtained through surveys, on-site visits, phone interviews
- Total Full-Time Direct employees estimated at 517
- Represents full-time, part-time, and seasonal jobs at each airport
- Considers off-airport jobs that support an airport's operation

- Almost 840 jobs
- Almost \$37 million in annual payroll
- Over \$134 million in total annual economic activity

Impacts of Airport Tenants

- Considers businesses at all airports that are engaged in the provision of aviation services or customer support
- Tenant information collected through surveys and phone and on-site interviews
- A total of 442 different airport tenants/businesses were identified
- These tenants have total direct employment estimated at 21,708

Impacts from Capital Improvement Projects (CIP)

- When capital projects are implemented, jobs and associated payroll are supported by the spending
- OAC provided airport specific state and FAA grant histories
- Airports provided information on local match and other airport-funded projects
- Tenants and airports provided data on third party investment
- Statewide average annual direct airport investment is almost \$200 million (labor and materials)

General Aviation Visitor Supported Impacts

- An estimated 154,300 visiting general aviation aircraft come to Oklahoma each year
- These general aviation planes bring an estimated 439,600 visitors to the state
- Annually, general aviation visitors have \$161.4 million in direct impacts
- Transient aerial applicators account for \$1.4 million of this total
- Annual spending supports jobs and associated payroll


Impacts from Visitors Arriving on Commercial Airlines

- Annually Oklahoma's four commercial airports enplane about 3.3 million passengers
- 1.4 million (43%) are visitors to the state
- These visitors support over \$1.4 billion in direct annual economic activity (spending and payroll)

State and Local Tax Revenues from Airports/Airport Supported Activities


SALES TAX REVENUES

- Airport spending for goods/supplies
- Tenant spending for good/supplies
- Taxable portion of goods/materials related to spending for capital projects
- Spending by all visitors arriving by air
- Average annual sales tax paid by all direct airport supported employees

STATE INCOME TAX

 Paid on salaries of all those working at airports or in support of airport activities

Almost \$500 Million in Airport Related Tax Revenue Contributions





Oklahoma Airports Support

- Aviation Educational and Training
 - 50 airports support education/training
 - 1,566 on- and off-airport direct jobs in aviation education/training
 - Oklahoma is a national leader in aviation education
- Aerial Applicators
 - 56 different airports support based/transient aerial applicators
 - Agriculture is a \$40 billion industry in Oklahoma
 - Aerial applicators generate an estimated \$22 million in economic benefits

Oklahoma Airports Support

- Healthcare
 - 70 airport report serving healthcare/emergency services
 - 38 hospitals report they rely on air transport to support healthcare
 - Rural hospitals are dependent upon staff who travel by air
- Oil and Gas Industry
 - Oklahoma is the Primary Delivery Point for Petroleum in the U.S.
 - 22 airports support pipeline patrols
- OHP
 - 30 airports support law enforcement and OHP activities
- Recreation
 - Fishing/hunting contribute \$1.5 billion to state economy
 - All airports support recreational activities

Oklahoma Airports Support Business Needs

- Proximity to commercial and general aviation airport important
- 51% of responding Oklahoma businesses benefit from general aviation
- 89% of responding Oklahoma businesses benefit from commercial aviation
- 48% benefit from overnight shipping/air cargo
- 34,787 jobs in Oklahoma have improved efficiency from use of aviation

Off-Airport Aviation/Aerospace Employers

Oklahoma City Metro "Off Airport"

- Over 307 aerospace/aviation establishments in the Oklahoma City Metro are not counted as airport tenants
- These 307 establishments employ about 9,200 workers at wages averaging over \$56,200 annually

Tulsa Metro "Off Airport"

- Over 286 aerospace/aviation establishments in the Tulsa Metro are not counted as airport tenants
- These 286 establishments employ over 10,100 workers at wages averaging over \$59,700 annually

Statewide Oklahoma "Off-Airport"

- Over 837 off-airport businesses are currently operating in the aerospace industry or are directly working with aerospace/aviation activities
- All off-airport aerospace companies statewide employ about 26,650 workers
- Off-airport companies paid average wages of over \$62,400 annually

Economic Impacts from Military

- Considers impacts related to the annual operation of each base
- Includes military, civilian, and contract personnel
- Includes impacts from spending to support annual capital investment to support military aviation
- Considers impacts from Vance, Altus, Tinker AFBs, and Oklahoma Air Guard


