*Fiscal Year 2013*



The Oklahoma Office of the Attorney General is required by Title 74, Section 20i(G) of Oklahoma Statutes to produce a written report on the private legal representation obtained by state agencies. This report is to include a brief description of each contract, the circumstances necessitating each contract, and the amount paid under each contract.

The Attorney General has made it a priority to reduce the amount of taxpayer dollars spent on private attorney contracts by increasing the number of state agencies the office represents through the General Counsel and Litigation units of the office. This has resulted in a substantial reduction in the dollars spent year over year on private attorneys during the term of Attorney General Scott Pruitt.

**Total Spent on Private Attorneys**

Fiscal Year 2011: \$ 11.78 million  
Fiscal Year 2012: \$ 9.15 million  
Fiscal Year 2013: \$ 7.53 million

By bringing more legal representation into the Office of the Attorney General we have reduced taxpayer dollars spent on legal representation, increased accountability for the legal work performed on behalf of Oklahoma, and enhanced the oversight of the legal services that the Attorney General's Office is providing. Our hope is to continue this trend by continuing to seek out the legal services that the Attorney General's Office should be providing on behalf of the State of Oklahoma.

The Attorney General is pleased to present the attached report of all private attorney contracts obtained during the Fiscal Year 2013 for your review.

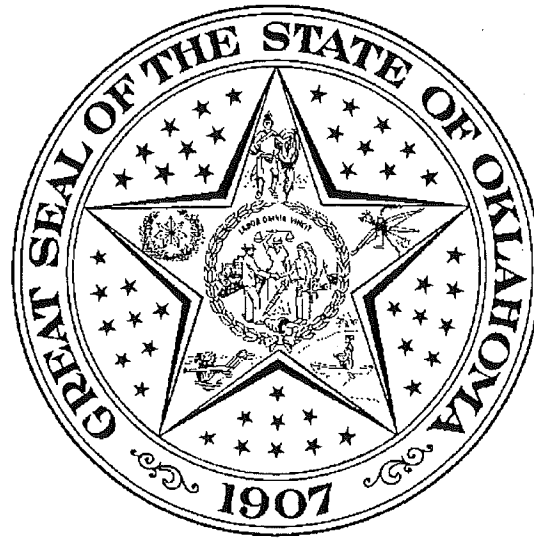

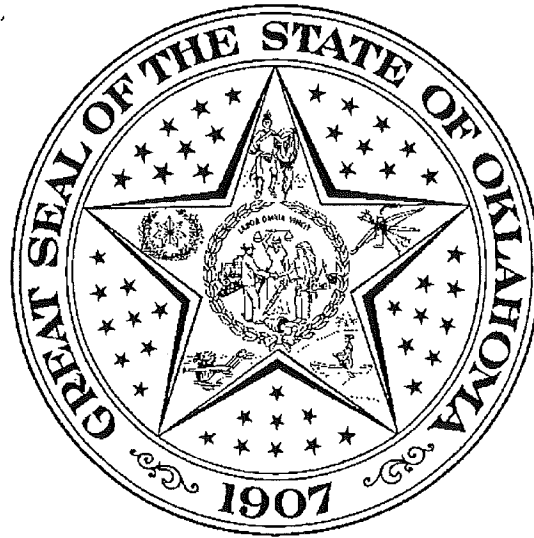
