Ingram moved behind the resident grabbing the hoodie portion of the resident's top, which caused the resident to collapse onto the floor. Ingram then dragged the resident across the room. An elderly couple living in Tulsa, contracted with Golden Care Home Health for personal care attendant services. Through the business relationship Brown-Hayes obtained, (and without authorization used), the identify and financial information of the elderly couple to pay Brown-Hayes' personal and/or business expenses. Colbert obtained a resident's debit card to make purchases for the resident, but improperly and illegally used the debit card (while in her possession) to pay her own personal expenses and make purchases for herself. Brown-Hayes, Ashley Nicole	Two Counts - Exploitation of Elderly Person 21 O.S. 843.4(A)(1) One Count - Identity Theft 21 O.S. 1533.1(B)	Ashley Brown-Hayes, owned and operated Golden Care Home Health. An elderly couple living in Tulsa, contracted with Golden Care Home Health for personal care attendant services. Brown-Hayes used deception to misappropriate funds from the couple's bank account and credit. To obtain the bank funds and credit card access Brown-Hayes willfully and fraudulently used the identity of her elderly victims.	September 22, 2022	Caretaker	Creek
McKinney, Randy Joe	One Count - Exploitation of Elderly Persons or Disabled Adult 21 O.S. 843.4(A)(1)	Between March 2016 and March 2019 Randy McKinney was the owner and administrator of Golden Life Residential Care in Craig County, Oklahoma. McKinney used his position as the owner and administrator to illegally obtain funds from a vulnerable resident of Golden Life.	September 26, 2022	Caretaker	Craig
