<b>Gibson, Kim</b>	Abuse by Caretaker 21 O.S. 843.1 (2 Counts)	Kim Gibson was working as a caregiver at Iris Memory Care, a long-term care facility on June 30, 2019 when she witnessed and failed to report that her co-worker Saleta Roberts sprayed Mace into the face of a vulnerable adult resident of the facility and failed to report that another resident was also exposed to the Mace. <b>McCaskill, Sue Ellen</b>	Felony Aggravated Assault and Battery 21 O.S. 646	Sue Ellen McCaskill was working as the Director of Nursing at Pauls Valley Care Center on March 31, 2020 (without legitimate medical treatment basis) caused Biofreeze to be applied to the genital area of a vulnerable adult causing pain and suffering to the person. <b>Ward, Penny Lynn</b>	Acts Resulting in Gross Injury 21 O.S. 22	Penny Ward was working as a CNA at Countryside Estates on April 5 <sup>th</sup> and 6 <sup>th</sup> 2018 when she assisted another Countryside caregiver place an elderly vulnerable adult back into bed after the person had fallen without first assuring a medical assessment was completed by a healthcare professional. <b>Williams, Cherone</b>	Financial Exploitation by Caretaker 21 O.S. 843.1(A) (Two (2) Counts)	Cherone Williams was working as a CNA at Ambassador Manor Nursing and Rehabilitation Center in December 2019 when she took two (2) debit cards from the room a vulnerable adult resident and used the debit cards to make in excess of \$5,000 dollars in purchases for herself. Between June 15 <sup>th</sup> and June 17 <sup>th</sup> , 2018 Rappe failed to direct staff or act himself in correcting filthy, deplorable living conditions for a vulnerable adult resident of Grace Living Center. <b>Moore, Melissa</b>	Neglect by Caretaker 21 O.S. 843.1	Melissa Moore was working as a CNA at Grace Living Center June 15 <sup>th</sup> through June 17 <sup>th</sup> , 2018 and responsible for providing care to vulnerable adults residing at Grace Living Center. Between June 15 <sup>th</sup> and June 17 <sup>th</sup> , 2018 Moore failed to provide minimum level of care resulting in filthy, deplorable living conditions for a vulnerable adult resident of Grace Living Center.
