#### AFFIDAVIT OF PROBABLE CAUSE

Justin Hokett, being of lawful age and after having been affirmed upon his oath to tell the truth, states as follows:

I am a certified Advanced Peace Officer in the State of Oklahoma, employed as an Agent in the Office of Oklahoma Attorney General (OAG) assigned to the Consumer Protection Unit (CPU). I attest that the following is true and factual to the best of my knowledge. This Affidavit does not include every fact known, but only those facts necessary to support a finding of probable cause.

In July of 2023, Brandy Ford (Ford) voluntarily reported to the Tulsa Police Department (TPD) that she was a witness to a crime. Ford told officers she worked as the exclusive real estate agent for T Briggs Construction, LLC, as well as a sales agent for Oasis Pools & Outdoor Living, LLC, for owner Todd Douglas Briggs (Briggs). Ford reported she assisted clients in contracting with Briggs for the construction of new homes and/or pools. Ford stated that Briggs recently informed her he was closing his businesses and was filing for bankruptcy. Ford advised officers that Briggs had multiple customers who paid Briggs in full for projects he did not complete and did not intend to complete because he was "out of money." TPD ultimately turned over the investigation to the OAG.

The CPU received seventeen (17) complaints against Briggs, sole owner and operator of T Briggs Construction, LLC and Oasis Pools & Outdoor Living, LLC. The complaints were all similar in nature, involving Briggs being paid funds for projects which he either never started, never finished, or didn't pay subcontractors and/or material suppliers for. This resulted in investigation CINV-23-0035 being opened and assigned to your Affiant.

Your Affiant served subpoenas to two financial institutions and obtained extensive documentation in response. This included account information for the accounts listed below, as well as loan documentation and W-4 filings, etc.:

#### **COMPLAINT 1 (Patricia Mann):**

On October 31, 2023, your Affiant conducted a voluntary interview of Patricia Mann (Mann). On May 12, 2023, Patricia and Rex Mann entered into a contract with T Briggs Construction, LLC, to build a residence at 2605 Falls Bend Drive, Sapulpa, OK 74066 Lot 11 Block 2 (Creek County), for \$462,884.00. By July 18, 2023, Mann had made six payments totaling \$83,585.84, as shown in Exhibit 1.

In July 2023, only days after Mann made her last payment to Briggs, Mann was contacted by Ford who advised her Briggs was closing his business and filing for bankruptcy. Following Briggs abandonment, Mann contracted with Jaroh Construction to finish the project. Your Affiant compared the Jaroh estimate to Briggs' draw sheet and identified a total of \$14,500.00 in completed work which was credited to Briggs.

In total, Briggs embezzled \$69,085.84. from Mann by taking payments and not using the funds to complete the work they were intended for. As such, your Affiant believes there is substantial evidence to charge Briggs with Embezzlement, Title 21 § 1451(A-1)(B-4).

### **COMPLAINT 2 (Melissa Boman):**

On September 13, 2023, your Affiant conducted a voluntary interview of Melissa Boman (Boman). On September 13, 2022, Melissa and Shea Boman entered into a contract with T Briggs Construction, LLC to build a residence at 4880 West 77th St, Tulsa, OK (Tulsa County), for \$590,250.00. By July 24, 2023, Boman had paid the full contract price, as shown in Exhibit 1.

Only days after receiving Boman's final payment, Briggs informed her that he was bankrupt and would not finish her project. According to documentation from First Pryority Bank (FBP), who held the mortgage loan, the house was approximately 84% complete based on FBP's last inspection. After Briggs abandoned the project, liens totaling \$77,023.45 were placed against Boman's property by unpaid subcontractors.

In total, Briggs embezzled \$171,423.45 from Boman by taking funds and not using the funds to pay for sub-contractors and/or materials associated with that payment's work or as

intended. As such, your Affiant believes there is substantial evidence to charge Briggs with Embezzlement, Title 21 § 1451(A-1)(B-4).

#### **COMPLAINT 3 (Carrie Garrett):**

On September 13, 2023, your Affiant conducted a voluntary interview of Carrie Garrett (Garrett). On May 8, 2023, an agreement was reached between Garrett and T Briggs Construction, LLC, for the building of a detached garage at 10809 N. 172nd E. Avenue, Owasso, OK 74055 (Rogers County), for \$59,400.00. By July 13, 2023, Garrett had made two payments totaling \$29,650.00, as shown in Exhibit 1.

Garrett stated that the slab was poured and rough-in plumbing within the slab was completed. However, only days after receiving Garrett's last payment, Briggs stopped construction and informed Garrett that he was filing for bankruptcy and would not be finishing her project. After Briggs abandoned the project, liens totaling \$13,380.14 were placed against the property by unpaid subcontractors.

In total, Briggs embezzled \$13,380.14 from Garrett by taking payments and not using the funds to pay for sub-contractors and/or materials associated with that payment's work. As such, your Affiant believes there is substantial evidence to charge Briggs with Embezzlement, Title 21 § 1451(A-1)(B-3).

## **COMPLAINT 4 (Shannon Williams):**

On October 25, 2023, your Affiant conducted a voluntary interview of Shannon Williams (Williams). On June 15, 2023, Williams entered into a contract with Oasis Pools & Outdoor Living, LLC, to construct a pool at 18706 E. 45th Place South, Tulsa, OK 74134 (Tulsa County), for \$108,000.00. By July 13, 2023, Williams had made two payments totaling \$86,400.00, as shown in Exhibit 1.

In late July 2023, only days after receiving Williams's last payment, Briggs informed her that he was filing for bankruptcy and closing his business. At that time, the only work performed by Briggs was partial excavation and some forming, which had collapsed. Gordan McAnally, owner of G & G Pools, was hired to finish the pool and estimated the work completed by Briggs to be worth no more than \$13,989.12.

In total, Briggs embezzled \$72,410.88 from Williams by taking payments and not using the funds to complete the work they were intended for. As such, your Affiant believes there is substantial evidence to charge Briggs with Embezzlement, Title 21 § 1451(A-1)(B-4).

#### **COMPLAINT 5 (Christian Lour):**

On October 25, 2023, your Affiant conducted a voluntary interview of Christian Lour (Lour). On April 24, 2023, Christian and Jovanna Kenney-Lour entered into a contract with T Briggs Construction, LLC, to construct a residence at 17075 N. 129th Ave, Collinsville, OK (Tulsa County), for \$308,250.00. By July 13, 2023, Lour had made three payments totaling \$53,665.00, as shown in Exhibit 1.

On July 25, 2023, only days after receiving Lour's last payment, Briggs notified Lour that he was bankrupt and would be abandoning the project. At that time the job site had been graded but no other work had begun or was completed by Briggs. Lour then contracted with Jaroh Construction to finish the project. Your Affiant compared the Jaroh estimate to Briggs' draw sheet for the property and identified a total of \$13,700.00 in completed work which was credited to Briggs.

In total, Briggs embezzled \$39,965.00 from Lour by taking payments and not using the funds to complete the work they were intended for. As such, your Affiant believes there is substantial evidence to charge Briggs with Embezzlement, Title 21 § 1451(A-1)(B-4).

#### **COMPLAINT 6 (Loy Hall):**

On October 4, 2023, your Affiant conducted a voluntary interview of Loy Hall (Hall). Hall entered into a contract with T Briggs Construction, LLC, on April 6, 2022, to build a residence at 9802 South Union Avenue, Jenks, OK 74132 (Tulsa County), for \$506,050.00. The property was within a new housing development known as "Jamestown" and it became 3320 West Jamestown Circle. By April 2023, Hall had paid the full contract price, as shown in Exhibit 1 attached.

Despite paying the full contract amount, Briggs completed only the concrete slab, stud framing, some roughed-in items, and a roof with shingles. Hall discovered Briggs was abandoning her project when he contacted her on July 25, 2023, stating he was "out of money." After Briggs abandoned the project, liens totaling \$48,026.84 were placed against Hall's property by unpaid subcontractors.

Hall contracted with True North Homes, LLC to finish the project. Your Affiant compared the True North estimate to Briggs' draw sheet for the property and identified a total of \$152,541.37 in completed work which was credited to Briggs.

In total, Briggs embezzled \$353,508.64 from Hall by taking funds and not using the funds to complete the work they were intended for. As such, your Affiant believes there is substantial evidence to charge Briggs with Embezzlement, Title 21 § 1451(A-1)(B-4).

#### **COMPLAINT 7 (Heidi Puglia):**

On October 31, 2023, your Affiant conducted a voluntary interview of Heidi Puglia (Puglia). On July 6, 2023, Frank and Heidi Puglia entered into a contract with Oasis Pools & Outdoor Living, LLC, to construct a pool at 2022 E. 133<sup>rd</sup> St South, Bixby, OK 74008 (Tulsa

County), for \$115,000.00. By July 20, 2023, Puglia had made two payments totaling \$57,500.00, as shown in Exhibit 1.

In late July 2023, only days after making her last payment, Puglia learned that Briggs was declaring bankruptcy and would not be returning to finish their pool construction. Puglia stated that Briggs dug a hole for the pool and some rebar was delivered, but no other work was done. Briggs left approximately 40 pieces of 10-foot, #3 rebar, worth approximately \$240.00, at the job site. Justin Carlson of Pool Remodels & Renovations of Tulsa, who finished the pool for Puglia, advised the excavation of the pool Briggs started was worth no more than \$10,000.00.

In total, Briggs embezzled \$47,260.00 from Puglia by taking payments and not using the funds to complete the work they were intended for. As such, your Affiant believes there is substantial evidence to charge Briggs with Embezzlement, Title 21 § 1451(A-1)(B-4).

## **COMPLAINT 8 (Ken Morton):**

On October 31, 2023, your Affiant conducted a voluntary interview of Kenneth Morton (Morton). On July 21, 2023, Ken and Rachel Morton entered into a contract with Oasis Pools & Outdoor Living, LLC, to construct a pool at 11336 S. Adams Street, Jenks, OK 74037 (Tulsa County), for \$129,500.00. On July 21, 2023, Morton made a payment of \$26,460.00, as shown in Exhibit 1.

On July 27, 2023, six days after signing the contract, Briggs informed Morton he was declaring bankruptcy and would not be constructing the pool. No work was performed by Briggs.

In total, Briggs embezzled \$26,460.00 from Morton by taking payment and not using it towards the work it was intended for. As such, your Affiant believes there is substantial evidence to charge Briggs with Embezzlement, Title 21 § 1451(A-1)(B-4).

# **COMPLAINT 9 (Siera Schwarz):**

On November 01, 2023, your Affiant conducted a voluntary interview of Siera Schwarz (Schwarz). On July 12, 2023, Siera and Michael Schwarz entered into a contract with T Briggs Construction, LLC, to renovate a residence at 13600 South Mingo Road, Tulsa, OK 74147 (Tulsa County), for \$371,780.00. On July 17, 2023, Schwarz made a payment of \$37,178.00, as shown in Exhibit 1.

On July 27, 2023, only days after accepting payment, Briggs informed Schwarz he was declaring bankruptcy and would not be starting the project. No work was performed by Briggs.

In total, Briggs embezzled \$37,178.00 from Schwarz by taking payment and not using it towards the work it was intended for. As such, your Affiant believes there is substantial evidence to charge Briggs with Embezzlement, Title 21 § 1451(A-1)(B-4).

#### **COMPLAINT 10 (Mackayla Baggett):**

On November 2, 2023, your Affiant conducted a voluntary interview of Mackayla Baggett (Baggett). On May 12, 2023, Mackayla and Dylan Baggett entered into a contract with T Briggs Construction, LLC, to construct a new home on unplotted land described in the contract as 0000 E. 9<sup>th</sup> Street, Beggs, OK 74421 (Okmulgee County), for \$557,740.00. By July 21, 2023, Baggett had made three payments totaling \$55,022.00, as shown in Exhibit 1.

On July 25, 2023, only days after Baggett made her last payment to Briggs, Ford informed the Baggett's that Briggs was declaring bankruptcy and would not be completing their project. Baggett stated the only work Briggs performed was forming a dirt pad and delivering gravel, worth \$3,000.00 per the contract.

In total, Briggs embezzled \$52,022.00 from Baggett by taking payments and not using it towards the work it was intended for. As such, your Affiant believes there is substantial evidence to charge Briggs with Embezzlement, Title 21 § 1451(A-1)(B-4).

#### **COMPLAINT 11 (Julie Patrick):**

On November 2, 2023, your Affiant conducted a voluntary interview of Julie Patrick (Patrick). On May 11, 2023, Julie and David Patrick entered into a contract with T Briggs Construction, LLC, to build a home at 18025 E. 112<sup>th</sup> Street North, Owasso, OK 74055 (Rogers County), for \$313,325.00. By July 21, 2023, Patrick had made two payments totaling \$34,556.50, as shown in Exhibit 1.

On July 26, 2023, only days after Patrick made her last payment to Briggs, she was informed Briggs was declaring bankruptcy and would no longer be their contractor. No work was performed by Briggs.

In total, Briggs embezzled \$34,556.50 from the Patricks by taking payments and not using the funds towards the work it was intended for. As such, your Affiant believes there is substantial evidence to charge Briggs with **Embezzlement**, **Title 21 § 1451(A-1)(B-4)**.

#### **COMPLAINT 12 (Travis Krimbill):**

On November 02, 2023, your Affiant conducted a voluntary interview of Travis Krimbill (Krimbill). On June 19, 2023, Travis and Kelsey Krimbill entered into a contract with Oasis Pools & Outdoor Living, LLC, to install a pool at 12406 S. Norwood Avenue, Bixby, OK 74008 (Tulsa County), for \$61,750.00. By June 19, 2023, Krimbill had paid the full contract price, as shown in Exhibit 1.

On July 27, 2023, barely a month after Krimbill paid Briggs in full, Briggs informed Krimbill he was declaring bankruptcy and would not begin work on the pool project. No work was performed by Briggs.

In total, Briggs embezzled \$61,750.00 from Krimbill by taking payment and not using it towards the work it was intended for. As such, your Affiant believes there is substantial evidence to charge Briggs with Embezzlement, Title 21 § 1451(A-1)(B-4).

#### **COMPLAINT 13 (Jarad Fisher):**

On November 20, 2023, your Affiant conducted a voluntary interview of Jarad Fisher (Fisher). On August 7, 2022, Jarad and Rhonda Fisher entered into a contract with T Briggs Construction, LLC, to construct a home and in-ground pool at 2210 E. Glendale Street, Broken Arrow, OK 74011 (Tulsa County), for \$701,530.00. During the course of construction, the Fishers requested four change orders to occur which increased the total cost of the contract to \$735,110.00, including the addition of a dozen mature trees. By May 25, 2023, Fisher had paid the contract price in full, as shown in Exhibit 1.

Following completion of the project, Fisher discovered the mature trees he paid for were never delivered. In addition, liens totaling \$90,883.68 were placed against the Fishers' property by unpaid subcontractors.

In total, Briggs embezzled \$95,683.68 from Fisher. As such, your Affiant believes there is substantial evidence to charge Briggs with Embezzlement, Title 21 § 1451(A-1)(B-4).

#### **COMPLAINT 14 (Jenna Harkreader):**

On November 20, 2023, your Affiant conducted a voluntary interview of Jenna Harkreader (Harkreader). On August 24, 2022, Jenna and Jack Harkreader entered into a contract with Oasis Pools & Outdoor Living, LLC, construct a pool house at 8328 E. 116<sup>th</sup> Street South, Bixby, OK 74008 (Tulsa County), for \$112,500.00. By July 21, 2023, Harkreader paid five payments totaling \$102,450.00, as shown in Exhibit 1.

In July 2023, only days after her last payment to Briggs, Briggs informed Harkreader he was bankrupt and would not be finishing their pool house. After Briggs abandonment, liens totaling \$9,665.50 were placed against Harkreader's property by unpaid subcontractors.

In total, Briggs embezzled \$9,665.50 from Harkreader by taking payments and not using it towards paying for work which it was intended for. As such, your Affiant believes there is substantial evidence to charge Briggs with Embezzlement, Title 21 § 1451(A-1)(B-3).

#### **COMPLAINT 15 (Joshua Miller):**

On November 20, 2023, your Affiant conducted a voluntary interview of Joshua Miller (Miller). On February 15, 2023, Joshua and Nicole Miller entered into a contract with T Briggs Construction, LLC, to build a home and pool at 1903 W 78th Street, Tulsa, OK 74132 (Tulsa County) for \$665,950.00. By June 23, 2023, Miller had paid five payments totaling \$221,367.50, as shown in Exhibit 1.

On July 25, 2023, barely a month after Miller's last payment to Briggs, Briggs informed Miller that he was bankrupt and would not be finishing the home or pool. Miller then contracted with Jaroh Construction to finish the project. Your Affiant compared the Jaroh estimate to Briggs' draw sheet and identified a total of \$30,834.85 in completed work which was credited to Briggs. Additionally, liens totaling \$76,180.85 were placed against the Miller's property by unpaid subcontractors.

In total, Briggs embezzled \$107,014.85 from Miller by taking funds paid to him and not using them towards the project. As such, your Affiant believes there is substantial evidence to charge Briggs with Embezzlement, Title 21 § 1451(A-1)(B-4).

#### **COMPLAINT 16 (Jamie Mehas):**

On November 20, 2023, your Affiant conducted a voluntary interview of Jamie Mehas (Mehas). On June 4, 2023, Jamie and Nicholas Mehas entered into a contract with Oasis Pools & Outdoor Living, LLC, to build a pool at 12720 South 4th Street, Jenks, OK 74037 (Tulsa County) for \$106,850.00. By July 6, 2023, Mehas had paid three payments totaling \$85,480.00, as shown in Exhibit 1.

On July 27, 2023, only three weeks after Mehas's last payment Briggs, Briggs her he was bankrupt and would not be finishing the pool. Mehas provided documentation to your Affiant substantiating she paid \$66,966.26 to complete the project. Additionally, after Briggs abandonment, a lien totaling \$16,710.00 was placed against the property by an unpaid subcontractor.

In total, Briggs embezzled \$62,306.26 from Mehas by taking payments and not using it towards paying for work and/or materials which it was intended for. As such, your Affiant believes there is substantial evidence to charge Briggs with Embezzlement, Title 21 § 1451(A-1)(B-4).

#### **COMPLAINT 17 (Sushil Hatkar):**

On January 23, 2024, your Affiant conducted a voluntary interview of Sushil Hatkar (Hatkar). On December 2, 2022, Hatkar entered into a contract with Oasis Pools & Outdoor Living, LLC, to install a pool at 5704 E. 100 Place, Tulsa, OK 74137 (Tulsa County), for \$135,000. By June 27, 2023, Hatkar had paid the contract price in full, as shown in Exhibit 1.

On July 21, 2023, less than a month after Hatkar's last payment to Briggs, Briggs contacted Hatkar stating he was bankrupt and would not be finishing the pool. The only remaining tasks left unfinished were the installation of the automated pool cover and re-sodding and landscaping the yard around the pool, which totaled \$11,360.00. Additionally, after Briggs abandonment, a lien totaling \$5,518.00 was placed against the property by an unpaid subcontractor.

In total, Briggs embezzled \$16,878.00 from Hatkar by taking funds and not using them towards paying for work and/or materials which it was intended for. As such, your Affiant believes there is substantial evidence to charge Briggs with Embezzlement, Title 21 § 1451(A-1)(B-4) Conclusion:

In total, Briggs utilized his companies to embezzle approximately \$1,270,548.74 from the 17 victims identified above.

I request upon probable cause, the court issue a warrant for the arrest of Todd D. Briggs on charges of Pattern of Criminal Offenses Title 21 § 425, two (2) felony counts Embezzlement, Title 21 § 1451(A-1)(B-3), and fifteen (15) felony counts Embezzlement, Title 21 § 1451(A-1)(B-4).

Further, your Affiant sayeth not.
