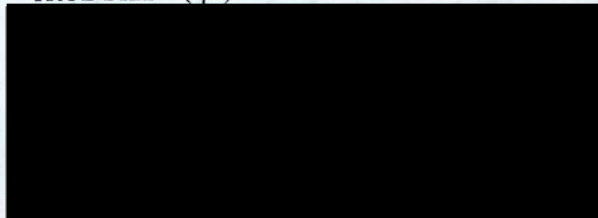


and triable within the State of Oklahoma, upon their oath, and in the name and by the authority of the State of Oklahoma, do present and find:

**COUNT 1: EMBEZZLEMENT BY COUNTY TREASURER, 19 O.S. § 641, a FELONY**

On or about August 11, 2020, the crime of **EMBEZZLEMENT BY COUNTY TREASURER**, was committed in Love County, State of Oklahoma, by **LORRY HULL**, who, while serving as the duly elected Love County Treasurer and being charged with the collection, receipt, safekeeping, transfer, or disbursement of public money or any part thereof belonging to Love County, did willfully, unlawfully, and feloniously convert public property to her own use from Love County, said property being entrusted to **LORRY HULL** by virtue of her office, to wit: by causing a treasurer's check to issue in the amount of \$5,489.67 payable to the Love County Treasurer, from the Love County Treasurer's account #XXXXXX2164 at BancFirst, cashing the check, and converting to her own use and benefits, or to uses unknown and not in keeping with the trust imposed upon her by law, contrary to the provisions of Section 641 of Title 19 of the Oklahoma Statutes and against the peace and dignity of the State of Oklahoma.

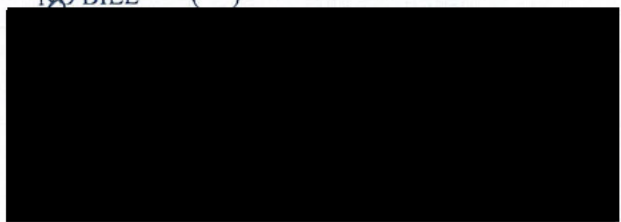


**COUNT 3: EMBEZZLEMENT BY COUNTY TREASURER, 19 O.S. § 641, a FELONY**

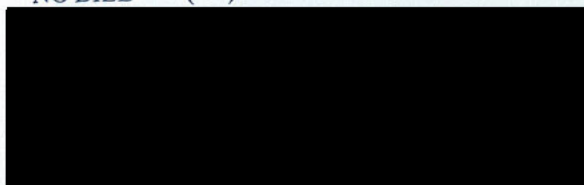


**COUNT 6: EMBEZZLEMENT BY COUNTY TREASURER, 19 O.S. § 641, a FELONY**

On or about July 27, 2020, the crime of **EMBEZZLEMENT BY COUNTY TREASURER**, was committed in Love County, State of Oklahoma, by **LORRY HULL**, who, while serving as the duly elected Love County Treasurer and being charged with the collection, receipt, safekeeping, transfer, or disbursement of public money or any part thereof belonging to Love County, did willfully, unlawfully, and feloniously convert public property to her own use from Love County, said property being entrusted to **LORRY HULL** by virtue of her office, to wit: by causing official depository voucher #6515 to issue in the amount of \$2,066.26 payable to the Love County Treasurer, from the Love County Treasurer's account #XXXX2718 at First National Bank, cashing the voucher, and converting to her own use and benefits, or to uses unknown and not in keeping with the trust imposed upon her by law, contrary to the provisions of Section 641 of Title 19 of the Oklahoma Statutes and against the peace and dignity of the State of Oklahoma.

On or about August 3, 2020, the crime of **EMBEZZLEMENT BY COUNTY TREASURER**, was committed in Love County, State of Oklahoma, by **LORRY HULL**, who, while serving as the duly elected Love County Treasurer and being charged with the collection, receipt, safekeeping, transfer, or disbursement of public money or any part thereof belonging to Love County, did willfully, unlawfully, and feloniously convert public property to her own use from Love County, said property being entrusted to **LORRY HULL** by virtue of her office, to wit: by causing check #015245 received from Housing Authority of Chickasaw Nation in the amount of \$960.00 payable to the Love County Treasurer to be deposited into the Love County Treasurer's account #XXXX2718 at First National Bank, withdrawing the \$960.00 in cash, and converting to her own use and benefits, or to uses unknown and not in keeping with the trust imposed upon her by law, contrary to the provisions of Section 641 of Title 19 of the Oklahoma Statutes and against the peace and dignity of the State of Oklahoma.
