# **COMPLAINT AND REQUEST FOR HEARING**

COMES NOW, the State of Oklahoma, ex rel. Gentner Drummond, Attorney General of Oklahoma ("Attorney General"), pursuant to 36 O.S. §§ 6966.1 et seq. and initiates this enforcement action against Respondents, Caremark, LLC, CaremarkPCS Health, LLC, and Caremark PHC, LLC, seeking (1) an order finding Respondents failed to comply with the respective provisions of 59 O.S. § 360 et seq., (2) the censure, suspension, or revocation of Respondents' licensure per 36 O.S. § 6966.1(B)(1), (3) the assessment of the necessary administrative fines, penalties, and restitution per 36 O.S. § 6966.1(B)(2)-(3), and (4) any further relief that may be appropriate and authorized by law. In support thereof, the Attorney General states as follows:

#### I. JURISDICTION AND AUTHORITY

The Attorney General is charged with the duty of enforcing all provisions of the Patient's
Right to Pharmacy Choice Act, the Pharmacy Audit Integrity Act, and the provisions of 59
O.S. §§ 357-360. 36 O.S. § 6965(A). The Attorney General's enforcement jurisdiction

includes the "power and authority to examine and investigate the affairs of every PBM engaged in pharmacy benefits management in this State in order to determine whether such PBM is in compliance with applicable State laws and regulations." *Id*.

- 2. Caremark, LLC, CaremarkPCS Health, LLC, and Caremark PHC, LLC ("Respondents") are pharmacy benefits managers ("PBMs") licensed by the State of Oklahoma. Respondent, Caremark, LLC (License No. 44201226) maintains a principal place of business at 1 CVS Dr. Woonsocket, Rhode Island 2895. Respondents CaremarkPCS Health, LLC, (License No. 4420128) and Caremark PHC, LLC (License No. 44201227), both have a principal place of business at 9501 E. Shea Blvd. Scottsdale, Arizona 85260. All Respondents have the same authorized registered agent in the State of Oklahoma located at 1833 S. Morgan Rd. Oklahoma City, Oklahoma 73128.
- 3. Under Oklahoma law, a PBM must be licensed to provide pharmacy benefits management, or any services included under the definition of pharmacy benefits management found in Oklahoma statutes, and must comply with all applicable State laws, rules, and regulations.
  59 O.S. § 358.
- 4. After notice and opportunity for hearing if there is a finding that a PBM is in violation of Oklahoma law, the Attorney General may instruct the Oklahoma Insurance Commissioner censure, suspend, or revoke a PBM's license. 36 O.S. § 6966.1(B)(1); 59 O.S. § 358(E)(1).
- 5. Additionally, the Attorney General may levy civil or administrative fines of not less than One Hundred Dollars (\$100.00) and not greater than Ten Thousand Dollars (\$10,000.00)

Respondents generally identify along with CVS Health Corporation's pharmacy benefits management subsidiary CVS Caremark or "Caremark." Their distinct formation relates to the differing (and complex) pharmacy networks they serve within the State.

- for each violation of the Patient's Right to Pharmacy Choice Act, the Pharmacy Audit Integrity Act, and the provisions of 59 O.S. §§ 357-360. 36 O.S. § 6966.1(B)(2); 59 O.S. §§ 358(E)(1)-(2).
- 6. The Attorney General may also order restitution for economic loss suffered by pharmacies or patients for violations of the Patient's Right to Pharmacy Choice Act, the Pharmacy Audit Integrity Act, and the provisions of 59 O.S §§ 357-360. 36 O.S. § 6966.1(B)(3).
- 7. Furthermore, the Attorney General is authorized to impose any penalty or remedy authorized under the Patient's Right to Pharmacy Choice Act against a PBM for violations of Patient's Right to Pharmacy Choice Act, the Pharmacy Audit Integrity Act, and the provisions of 59 O.S §§ 357-360. 36 O.S. § 6966.1(C).
- 8. The Office of Administrative Hearings maintains jurisdiction over the parties and the subject matter contained within this Complaint as authorized by the Attorney General. 36 O.S. § 6966.1(E)(1)-(2); OAC 75:45-1-1 et seq.

## II. FACTUAL ALLEGATIONS

- 9. Respondents, along with other PBMs licensed and doing business in Oklahoma, generally utilize the following business practices:
  - a. Within a complex prescription drug supply chain, PBMs coordinate prescription drug benefits for members of health insurance plan clients. Pharmaceutical benefits are provided through creating networks of covered pharmacies and negotiating drug pricing with pharmaceutical manufacturers to ensure clients are paying the best prices for drugs prescribed to their members.
  - b. Pharmacy networks are built upon direct contracts with pharmacies, or pharmacy

services administrative organizations ("PSAOs").<sup>2</sup> Said contracts are often referred to as Pharmacy Participation Agreements. These contracts allow for a pharmacy to fill prescriptions for members of a PBM's prescription benefits plan(s).

- c. Within a contract between a PBM and a pharmacy, provisions relating to how the pharmacy will be reimbursed is often the most consequential. Reimbursement provisions usually take standard form across the pharmacy benefits management industry, as PBMs generally incorporate rates for reimbursement for filling a prescription from a PBM's prescription drug formulary. Varying rates for reimbursement can be included within a single agreement. For multi-sourced drugs, PBM contracts incorporate a maximum allowable cost ("MAC") list as a guide for pricing.
- d. Alternatively, each individual pharmacy contracting with any number of PBMs is independently responsible for purchasing its own inventory from pharmaceutical drug wholesalers. Pharmacies also negotiate respective contracts with wholesalers to ensure access to prescription drugs at cost effective prices, i.e., primary wholesale agreements.
- e. Routinely, however, these same pharmacies are reimbursed by PBMs at amounts less than what it costs to purchase the drug. This is known as *below-cost reimbursement*.
- f. Below-cost reimbursement causes pharmacies to lose money on filling prescriptions for their patients despite attempts to rely upon previously agreed upon bases for reimbursement.
- g. With respect to reimbursement, small-chain or independent pharmacies' (or their

PSAOs') contract negotiation power with PBMs is aggressively imbalanced. Pharmacies acquiesce to PBM contracts with unfavorable terms, subsequently subjecting themselves to economic loss as the alternative route creates far more risk. The alternative, to forgo contracting with a PBM, inherently alienates patients covered under specific pharmacy benefits plan. Without the necessary PBM contract, impacted patients are subject to paying out of pocket for a prescription (if electing to use a pharmacy, despite it not being in network) or losing access to the pharmacy. In rural Oklahoma this can be detrimental to patients' healthcare access as there is often a single pharmacy for miles at a time.

- 10. The Attorney General received numerous complaints from independent, Oklahoma pharmacies alleging below-cost reimbursement by Respondents. Numerous complaints were also received from a PSAO, AlignRx, alleging the same against Respondents on behalf of its member pharmacies. The pharmacies independently filing complaints or having them filed on their behalf via AlignRx include: 412 Family Pharmacy, Broken Arrow Family Drug, Cedar Springs Pharmacy, The Clinic Pharmacy, Crescent Care Pharmacy, Curtin Drug, Doctor's Park Pharmacy, Elliot Plaza Pharmacy, Medic Pharmacy, Medic Pharmacy at Hefner Pointe, Miller Drug, Pill Box Pharmacy, R&S Drug Store 1 LLC, Thompson's Pharmacy, and United Discount Pharmacy.
- 11. Wherein, the Attorney General commenced an investigation against Respondents based upon the allegations provided and found the following were in violation of Oklahoma law:

12. At all times relevant herein, Respondents were engaged in pharmacy benefits management, as defined under Oklahoma statutes, in the State of Oklahoma.

# III. ALLEGED VIOLATIONS OF LAW

13. Pursuant to 59 O.S. § 360 (A)(5), if a below-cost reimbursement appeal is denied by the

- PBM, the PBM shall "provide the reason for denial, including the National Drug Code ("NDC") number from, and the name of, the specific national or regional wholesalers doing business in this state where the drug is currently in stock and available for purchase by the dispensing pharmacy at a price below the PBM's reimbursement price."
- 14. 59 O.S. § 360 (A)(5) also provides if the NDC number provided is not available, the PBM "shall immediately adjust the reimbursement amount, permit the dispensing pharmacy to reverse and rebill the claim in question, and make the reimbursement amount adjustment retroactive and effective for all contracted providers." An NDC number is *not available* if it cannot be obtained below acquisition cost "from the pharmaceutical wholesaler from whom the dispensing pharmacy purchases the majority of the prescription drugs that are dispensed." *Id.* (Emphasis added).
- 15. Per the claims provided in Table 1, between May 20, 2024, and October 3, 2024, Respondents violated 59 O.S. § 360(A)(5) two hundred (200) times by failing to:
  - a. Provide an alternate NDC number which was available for purchase by the pharmacist
    at the time the pharmacist originally filled the prescription for the patient;
  - b. Immediately adjust the reimbursement amount and permit the dispensing pharmacy to reverse and rebill the claim in question; and/or
  - c. Make the reimbursement amount adjustment retroactive and effective for all contracted pharmacy providers.
- 16. Pursuant to 59 O.S. § 360(A)(4), Respondents shall "provide a reasonable administration appeals procedure ... to contest reimbursement amounts within fourteen (14) calendar days of the final adjusted payment date." Respondents shall not prevent an individual pharmacy, or a PSAO, from filing reimbursement appeals in an electronic batch format. *Id*.

17. Respondents also violated 59 O.S. § 360(A)(4) fifteen (15) times by failing to provide these pharmacies or their PSAO with a reasonable administration appeals procedure.<sup>4</sup>

#### V. DAMAGES

WHEREFORE, premises considered, the Attorney General prays this Court order (1) the censure, suspension, or revocation of Respondents' licensure, (2) assess monetary fines of not less than One Hundred Dollars (\$100.00) and not greater than Ten Thousand Dollars (\$10,000) for each respective violation of 59 O.S. § 360(A)(5) and 59 O.S. § 360(A)(4), (3) assess restitution equivalent to the economic loss suffered by the local pharmacies named in this Complaint, and (4) any other further relief which may be appropriate and authorized by law.

### VI. REQUEST FOR HEARING

The Attorney General requests a formal administrative hearing be set before the Oklahoma Office of Administrative Hearings in accordance with the Oklahoma Administrative Procedures Act and administrative rules for Oklahoma Pharmacy Benefit Compliance and Enforcement. 75 O.S. § 309 et seq.; O.A.C. 75:45-2-1 et seq. A hearing is necessary for Respondents to show cause as to why they should not be subject to requested administrative penalties pursuant to 36 O.S. § 6966.1 et seq.

<sup>&</sup>lt;sup>4</sup> A reasonable appeals procedure is "a process which permits a provider or a provider's representative to contest a multisource drug product reimbursement amount based on the provider's contention that the drug is not generally available for purchase by Oklahoma pharmacies in the state at or below the PBM's multisource drug product reimbursement." O.A.C. 75:45-3-4(a)(1)(C).
