IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OKLAHOMA:

By the order of the Supreme Court of Oklahoma, the Twenty-First Multi-County Grand Jury of Oklahoma was convened with its principal site to be in Oklahoma City, Oklahoma County, Oklahoma, to serve from December 16, 2024, for eighteen (18) months, or until the designated presiding judge determines the Twenty-First Multi-County Grand Jury has reached reasonable completion of its investigations, but, in any event, no more than twenty-four (24) months from the commencement of its term. That said Multi-County Grand Jury of the State of Oklahoma, being composed of good and lawful men and women, legally drawn and summoned according to law, and then and there examined, impaneled, sworn, and charged according to law to diligently inquire into, and true presentment make, of all public offenses against the State of Oklahoma committed within the State of Oklahoma, upon their oath, and in the name and by the authority of the State of Oklahoma, do present and find:

COUNT 1: CONSPIRACY TO OBTAIN PROPERTY (\$15,000 OR MORE) BY FALSE PRETENSES – TWO OR MORE BOGUS CHECKS ~ 21 O.S.2021, § 421, a FELONY

On or about September 18, 2023, in Oklahoma County, Oklahoma, the crime of **CONSPIRACY TO OBTAIN PROPERTY (\$15,000 OR MORE) BY FALSE PRETENSES – TWO OR MORE BOGUS CHECKS**, was committed by **KRYSTY JEAN SCHOLE**s and **EARL WAYNE SALISBURY**, who conspired with one another, by agreeing to obtain various items of merchandise from retailers by writing fraudulent checks totaling \$21,297.77, from fictitious bank accounts, in violation of Section 1541.3(A)(3) of Title 21, contrary to the provisions of Section 421 of Title 21. In furtherance of their conspiracy, a member or members of the conspiracy did commit one or more of the following overt acts:

- a. On or about September 18, 2023, **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY** drove to the Walmart Supercenter located at 1200 S. Garth Brooks Blvd., Yukon, Oklahoma 73099, in a red Toyota Highlander, and **KRYSTY SCHOLES** obtained various items using a fraudulent check in the amount of \$834.60.
- b. On or about September 19, 2023, **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY** drove to a Walmart Supercenter located at 3301 S.W. 104th Street, Shawnee, Oklahoma 73159, in a red Toyota Highlander, and **EARL WAYNE SALISBURY**, made returns of various items and fraudulently obtained and received refunded cash.
- c. On or about September 26, 2023, **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY** drove to an Academy Sports + Outdoors in a red Toyota Highlander, located at 2010 N.W. 24th Street, Norman, Oklahoma 73069, and **KRYSTY JEAN SCHOLES** obtained various items by using a fraudulent check in the amount of \$541.55.
- d. Later that day, **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY**, drove to an Academy Sports + Outdoors in a red Toyota Highlander, located at 4261 N.W. 63rd Street, Oklahoma City, Oklahoma 73116, and **KRYSTY JEAN SCHOLES** returned some of the same items fraudulently obtained at the Norman Academy Sports + Outdoors and received refunded cash.
- e. Around September 25, 2023, **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY** drove to The Home Depot located at 7620 N.W. Expressway, Oklahoma City, Oklahoma 73132, and **KRYSTY JEAN SCHOLES** fraudulently obtained items with a fraudulent check in the amount of \$877.99.
- f. On or about October 7, 2023, **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY** drove to a Walmart Supercenter located at 501 S.W 19th Street, Moore, Oklahoma 73160, in a red Toyota Highlander, and **EARL WAYNE SALISBURY**, made returns of various items fraudulently obtained and received refunded cash.
- g. On or about November 17 and 18, 2023 **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY** drove to D & D Feed at 5616 S. Harrah Rd., Newalla, Oklahoma 74857, and N & R Feed at 20878 S. Main Street., Harrah, Oklahoma 73045, in a gray Dodge Ram Pickup, and **KRYSTY JEAN SCHOLES** fraudulently obtained various items with fraudulent checks totaling an amount of \$1,805.21.
- h. On or about December 26, 2023, **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY** drove to TH Rogers Lumber at 713 S. Green Avenue, Purcell, Oklahoma 73080, and **KRYSTY JEAN SCHOLES** obtained various items with a fraudulent check in the amount of \$440.07.

- i. On or about December 29, 2023, **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY** drove to Hometown Hardware at 1275 Piedmont Rd. N., Piedmont, Oklahoma 73078, and **KRYSTY JEAN SCHOLES** obtained various items with a fraudulent check in the amount of \$557.25.
- j. On or about January 5, 2024, **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY** drove to TH Rogers Lumber at 401 S. Willow Street, Pauls Valley, Oklahoma 73075, in a red Toyota Highlander and **KRYSTY JEAN SCHOLES** obtained various items with a fraudulent check in the amount of \$500.39.
- k. On or about February 2, 2024, **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY** drove to Tuttle Country Store at 1 N.W. 5th Street, Tuttle, Oklahoma 73089, in a gray Dodge Ram Pickup, and **KRYSTY JEAN SCHOLES** obtained various items with a fraudulent check in the amount of \$654.59.
- l. On or about March 12, 2024, **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY** drove to TH Rogers Lumber at 401 S. Willow Street, Pauls Valley, Oklahoma 73075, and **KRYSTY JEAN SCHOLES** obtained various items using a fraudulent check in the amount of \$542.79.
- m. On or about April 29, 2024, **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY** drove to Wheeler Brothers Grain Company at 760 W. Robberts Avenue, Kingfisher, Oklahoma 73750, and **KRYSTY JEAN SCHOLES** obtained various items using a fraudulent check in the amount of \$477.15
- n. On or about May 9, 2024, **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY** drove to Banner CO-OP at 4175 N. Banner Rd., El Reno, Oklahoma 73036, and **KRYSTY JEAN SCHOLES** obtained various items with a fraudulent check in the amount of \$726.89.
- o. On or about October 26, 2024, **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY** drove to TH Rogers Lumber at 713 S. Green Avenue, Purcell, Oklahoma 73080, and **KRYSTY JEAN SCHOLES** obtained various items with a fraudulent check in the amount of \$2,379.67.
- p. On or about November 26, 2024, **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY** drove to O'Reilly Auto Parts at 257 E. State Highway 152, Mustang, Oklahoma 73064, in a gray Dodge Ram Pickup, and **KRYSTY JEAN SCHOLES** obtained various items using a fraudulent check in the amount of \$870.76.
- q. On or about February 10, 2025, **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY** drove to O'Reilly Auto Parts at 555 N.W. 32nd Street, Newcastle, Oklahoma 73065, and obtained various items with a fraudulent check in the amount of \$585.13.

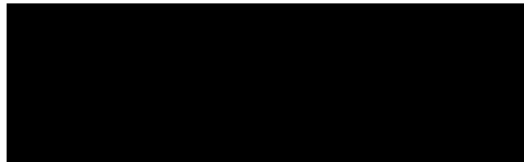
- r. On or about March 5, 2025, **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY** drove to H.I.S. Paint at 1801 W. Reno Avenue, Oklahoma City, Oklahoma 73106, and **KRYSTY JEAN SCHOLES** obtained various items with a fraudulent check in the amount of \$2,023.02
- s. On or about March 9, 2025, **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY** drove to Mattress King at 208 S. Portland Avenue, Oklahoma City, Oklahoma 73108, and **KRYSTY JEAN SCHOLES** obtained various items with a fraudulent check in the amount of \$2,259.18.
- t. On or about March 16, 2025, **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY** drove to Factory Direct Mattress at 2408 Thomas Drive #112, Edmond, Oklahoma 73003, and **KRYSTY JEAN SCHOLES** obtained various items with a fraudulent check in the amount of \$3,266.17.
- u. On or about March 17, 2025, **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY** drove to Classic Chevrolet at 8900 N.W. Expressway, Oklahoma City, Oklahoma 73162, and **KRYSTY JEAN SCHOLES** obtained various items with a fraudulent check in the amount of \$1,255.36.

COUNT 2: OBTAINING PROPERTY (\$15,000 OR MORE) BY FALSE PRETENSES – TWO OR MORE BOGUS CHECKS ~ 21 O.S.2021, § 1541.3(A)(3), a FELONY

On or about or between September 18, 2023, and March 17, 2025 in Oklahoma County, Oklahoma, the crime of **OBTAINING PROPERTY (\$15,000 OR MORE) BY FALSE PRETENSES – TWO OR MORE BOGUS CHECKS**, was feloniously committed by **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY** by obtaining title to property from various retail stores, including Walmart Supercenter, Academy Sports + Outdoors, The Home Depot, D & D Feed, N & R Feed, O'Reilly Auto Parts, TH Rogers Lumber, H.I.S. Paint, Mattress King, Factory Direct Mattress, Hometown Hardware, Banner CO-OP, Tuttle Country Store, Classic Chevrolet, and Case & Associates, by using two or more fraudulent checks totaling \$21,297.77, which **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY** knew to be fraudulent, in pursuance of a common scheme, and with the intent to defraud these various retailers.

On or about August 7, 2024, in Oklahoma County, Oklahoma, the crime of **CONSPIRACY TO FALSELY IMPERSONATE ANOTHER** was committed by **KRYSTY JEAN SCHOLES** and **EARL WAYNE SALISBURY**, who conspired with one another for **KRYSTY JEAN SCHOLES** to falsely assume the identity of Tasha Dyer-Joyner, knowing that said impersonation of Tasha Dyer-Joyner was intentional and for the sake of presenting a fraudulent check to Factory Direct Mattress, a retail business, located at 2408 Thomas Drive #112, Edmond, Oklahoma 73003, with the intent that said fraudulent check be used as true, in violation of Section 1531(3) of Title 21, contrary to the provisions of Section 421 of Title 21. In furtherance of their conspiracy, a member or members of the conspiracy did commit one or more of the following overt acts:

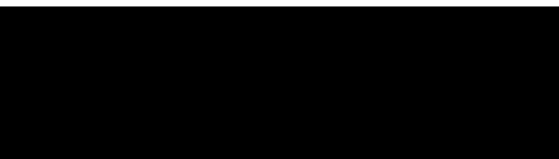

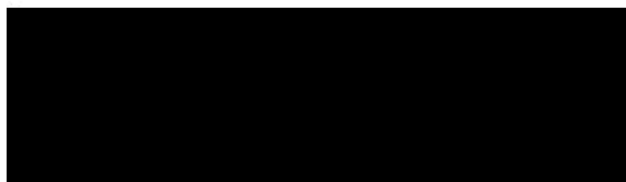
On or about or between September 18, 2023 and March 18, 2025 the crime of **ENGAGING IN A PATTERN OF CRIMINAL OFFENSES** was feloniously committed by **KRYSTY JEAN SCHOLE**s and **EARL WAYNE SALISBURY** by perpetrating criminal offenses – including the crimes of conspiracy to obtain property by false pretenses, obtaining property by false pretenses, conspiracy to falsely impersonate another, false personation of another, and fraudulently obtaining the personal identity of another person – in two or more counties in the State of Oklahoma, with said offenses occurring in Oklahoma County, Canadian County, Cleveland County, Pottawatomie County, Garvin County, Kingfisher County, Grady County, and McClain County, with such offenses being committed as part of the same plan, scheme, or adventure, and/or with such offenses each proceeding from or having antecedent a single prior incident or pattern of fraud, theft, identity theft, receipt of stolen property, false personation, false pretenses, obtaining property by trick or deception, taking a credit or debit card without consent, or the making, transferring, or receiving a false or fraudulent identification card. Such pattern of offenses included acts which occurred at 1200 S. Garth Brooks Blvd., Yukon, Oklahoma 73099, in Canadian County; 3301 S.W. 104th Street, Shawnee, Oklahoma 73159, in Pottawatomie County; 501 S.W. 19th Street, Moore, Oklahoma 73160, in Cleveland County; 2010 N.W. 24th Street, Norman, Oklahoma 73069, in Cleveland County; 4261 N.W. 63rd Street, Oklahoma City, Oklahoma 73116, in Oklahoma County; 7620 N.W. Expressway, Oklahoma City, Oklahoma 73132, in Oklahoma County; 5616 S. Harrah Rd., Newalla, Oklahoma 74857, in Oklahoma County; 20878 S. Main Street, Harrah, Oklahoma 73045, in Oklahoma County; 713 S. Green Avenue, Purcell, Oklahoma 73080, in McClain County; 1275 Piedmont Rd. N., Piedmont, Oklahoma 73078, in Canadian County; 401 S. Willow Street, Pauls Valley, Oklahoma 73075,

Garvin County; 1 N.W. 5th Street, Tuttle, Oklahoma 73089, in Grady County; 760 W. Robberts Avenue, Kingfisher, Oklahoma 73750, Kingfisher County; 4175 N. Banner Rd., El Reno, Oklahoma 73036, Canadian County; 713 S. Green Avenue, Purcell, Oklahoma 73080, McClain County; 257 E. State Highway 152, Mustang, Oklahoma 73064, Canadian County; 555 N.W. 32nd Street, Newcastle, Oklahoma 73065; McClain County; 1801 W. Reno Avenue, Oklahoma City, Oklahoma 73106, Oklahoma County; 208 S. Portland Avenue, Oklahoma City, Oklahoma 73108, Oklahoma County; 2408 Thomas Drive #112, Edmond, Oklahoma 73003, Oklahoma County; 8900 N.W. Expressway, Oklahoma City, Oklahoma 73162, Oklahoma County. Additionally, said pattern was further perpetrated by virtue of committing the offense of false personation, which occurred at 2408 Thomas Drive #112, Edmond, Oklahoma 73003, Oklahoma County; 208 S. Portland Avenue, Oklahoma City, Oklahoma 73108, Oklahoma County; 555 N.W. 32nd Street, Newcastle, Oklahoma 73065; McClain County; and 8900 N.W. Expressway, Oklahoma City, Oklahoma 73162, Oklahoma County. These acts constituted a pattern of criminal offenses, contrary to the provisions of Section 425 of Title 21 of the Oklahoma Statutes and against the peace and dignity of the State of Oklahoma.

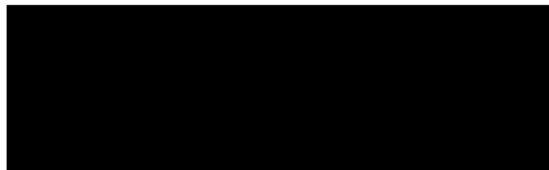

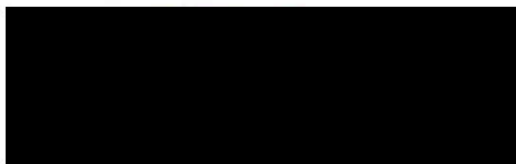
