- COUNT 1: CONSPIRACY TO COMMIT HUMAN TRAFFICKING FOR COMMERCIAL SEX ~ 21 O.S. § 421, a FELONY
- COUNT 2: HUMAN TRAFFICKING FOR COMMERCIAL SEX ~ 21 O.S. § 748(A)(6), a FELONY
- COUNT 3: HUMAN TRAFFICKING COMMERCIAL SEX ~ 21 O.S. § 748(A)(6), a FELONY
- COUNT 4: HUMAN TRAFFICKING COMMERCIAL SEX ~ 21 O.S. § 748(A)(6), a FELONY

IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OKLAHOMA:

By the order of the Supreme Court of Oklahoma, the Twenty-First Multi-County Grand Jury of Oklahoma was convened with its principal site to be in Oklahoma City, Oklahoma County, Oklahoma, to serve from December 16, 2024, for eighteen (18) months, or until the designated presiding judge determines the Twenty-First Multi-County Grand Jury has reached reasonable completion of its investigations, but, in any event, no more than twenty-four (24) months from the commencement of its term. That said Multi-County Grand Jury of the State of Oklahoma, being composed of good and lawful men and women, legally drawn and summoned according to law, and then and there examined, impaneled, sworn, and charged according to law to diligently inquire into, and true presentment make, of all public offenses against the State of Oklahoma committed within the State of Oklahoma, upon their oath, and in the name and by the authority of the State of Oklahoma, do present and find:

COUNT 1: CONSPIRACY TO COMMIT HUMAN TRAFFICKING FOR COMMERCIAL SEX ~ 21 O.S. § 421, a FELONY

On or about or between April 25, 2025, and July 1, 2025, the crime of **CONSPIRACY TO COMMIT HUMAN TRAFFICKING FOR COMMERCIAL SEX**, was feloniously committed by **ANDERSON WALKER, BRANDI MCDANIELS, and LESLIE BROWN**, who conspired with one another, to knowingly recruit, entice, harbor, maintain, transport, provide and/or obtain another person or persons, to wit: A.P. and/or D.B., through deception, force, fraud, threat, and/or coercion for the purpose of engaging A.P. and/or D.B. in commercial sex, acts which were in violation of Section 748(A)(6) of Title 21, in a conspiracy that was contrary to the provisions of Section 421 of Title 21 and against the peace and dignity of the State of Oklahoma.

In furtherance of their conspiracy, a member or members of the conspiracy did commit one or more of the following overt acts:

- a. On or about May 12, 2025, through June 1, 2025, **LESLIE BROWN** and/or **ANDERSON WALKER** drove D.B. to the Budget Inn of OKC, located at 4017 N.W. 39th Street, Oklahoma City, Oklahoma 73112, for the purpose of renting a motel room to engage in acts of commercial sex.
- b. On or about May 15, 2025, **LESLIE BROWN** drove D.B. to the Biltmore Hotel, located 401 S. Meridan Avenue, Oklahoma City, Oklahoma 73108, where D.B. rented a motel room for one night to engage in acts of commercial sex.
- c. On or about June 4, 2025, **LESLIE BROWN** drove D.B. to the Super 8 Motel, located 2821 N.W. 39th Street, Oklahoma City, Oklahoma 73112, where D.B. rented a motel room for one night to engage in acts of commercial sex.
- d. On or about May 12, 2025, through June 20, 2025, **LESLIE BROWN** placed her phone number on commercial sex advertisements for D.B. and controlled and set dates for D.B. at various locations, as well as prices for commercial sex dates.
- e. On or about May 12, 2025, through July 1, 2025, D.B. would send money she made from commercial sex dates to **LESLIE BROWN** and **BRANDI MCDANIELS**, who would then send the money to **ANDERSON WALKER**.
- f. On or about June 18, 2025, through July 1, 2025, **ANDERSON WALKER** and **BRANDI MCDANIELS** exchanged numerous texts with Walker's phone number, (405) 934-5113, involving D.B. and A.P. regarding dates being set up, money being collected, and where D.B. and A.P. were located.
- g. On or about June 19, 2025, through July 1, 2025, **ANDERSON WALKER** exchanged numerous text messages with A.P. involving her "modeling" contract, how much money she needed to make, how many dates she needed to have before the next day,

and telling her that she will “get left there and motherfucking Kansas City bitch don’t tempt me” if she did not get money. **ANDERSON WALKER** also talked about meeting “quota” several times in the same text thread and that “Fatz” a.k.a. **BRANDI MCDANIELS** was “handling everything.”

- h. On or about June 22, 2025, through June 24, 2025, **LESLIE BROWN** drove A.P. to the Super 8 Motel, located at 2821 N.W. 39th Street, Oklahoma City, Oklahoma 73112, for the purpose of renting motel rooms to engage in acts of commercial sex.
- i. On or about June 25, 2025, through June 28, 2025, **BRANDI MCDANIELS** drove A.P. to Kansas City, Missouri, and rented numerous rooms at the Days Inn Hotel, located at 3636 N.E. Randolph Rd., Kansas City, Missouri 64161, and Wingate Hotel, located at 7333 N.E. Parvin Rd., Kansas City, Missouri 64117, for the purpose of engaging in commercial sex.
- j. On or about June 22, 2025, through July 1, 2025, **BRANDI MCDANIELS** and **ANDERSON WALKER** created commercial sex advertisements for A.P.
- k. On or about June 24, 2025, through July 1, 2025, **BRANDI MCDANIELS** and **ANDERSON WALKER** exchanged numerous texts with Walker’s phone number, (572) 572-0533, involving D.B. and A.P. **BRANDI MCDANIELS** also sent large amounts of money to **ANDERSON WALKER** via ApplePay.
- l. On or about June 28, 2025, **BRANDI MCDANIELS** used A.P.’s cell phone to text with sex clients to set up commercial sex dates and dictated the price for clients to engage in commercial sex with A.P. while she was staying at the Days Inn Hotel in Kansas City, Missouri.

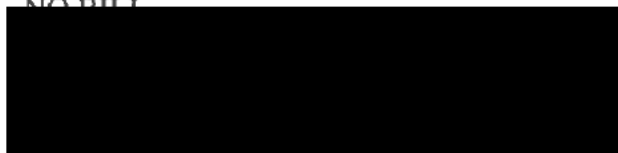
- m. On or about June 29, 2025, through July 2, 2025, **LESLIE BROWN** and **BRANDI MCDANIELS** arrived at the Budget Inn, located at 4017 N.W. 39th Expressway, Oklahoma City, Oklahoma 73112, where A.P. was staying to perform commercial sex dates, took A.P.'s cell phone from her in order to control the commercial sex ads, and arranged commercial sex dates for A.P.
- n. On or about June 29, 2025, **ANDERSON WALKER** communicated with **BRANDI MCDANIELS** that D.B. was "no longer....ICU."
- o. On or about June 30, 2025, **BRANDI MCDANIELS** used A.P.'s cell phone to text with sex clients to set up commercial sex dates and dictated the price for clients to engage in commercial sex with A.P. while she was staying at the Budget Inn, located at 4017 N.W. 39th Expressway, Oklahoma City, Oklahoma 73112.
- p. On or about June 30, 2025, **LESLIE BROWN's** CashApp handle "\$LeslieBrown77" was sent to a sex client in order for that sex client to send money for the sex date with A.P.
- q. On or about July 1, 2025, **BRANDI MCDANIELS** sent her phone number to a sex client in order for that sex client to send money via Zelle to her for a sex date with A.P.

On or about or between June 1, 2024 and February 1, 2025, the crime of **HUMAN TRAFFICKING FOR COMMERCIAL SEX**, was feloniously committed by **ANDERSON WALKER**, who knowingly recruited, enticed, harbored, maintained, transported, provided and/or obtained another person, to wit: S.L., through deception, force, fraud, threat, and/or coercion for the purpose of engaging S.L. in commercial sex and knowingly benefiting from said activity by threats of harm against the person, and/or claiming money from S.L. where such demand arises from the act of prostitution, contrary to the provisions of Section 748 of Title 21 and against the peace and dignity of the State of Oklahoma.

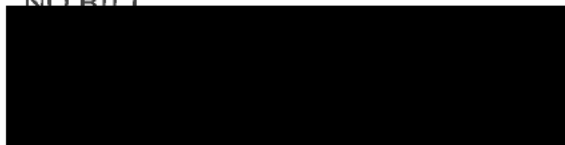
On or about or between May 1, 2025, and July 1, 2025, the crime of **TRANSPORTING A PERSON FOR PROSTITUTION**, was feloniously committed by **ANDERSON WALKER, BRANDI MCDANIELS**, and **LESLIE BROWN**, who directed, took, transported, or offered or agreed to take or transport, or aided or assisted in transporting, another person or persons, to wit: D.B. and/or A.P., to any house, place, building, other structure, vehicle, trailer, or other conveyance, or to any other person with knowledge or reasonable cause to believe that the intent of such directing, taking, or transporting was for D.B. and/or A.P. to engage in prostitution, contrary to the provisions of Section 1028(A)(5) of Title 21 and against the peace and dignity of the State of Oklahoma.

On or about or between May 1, 2025, and July 1, 2025, the crime of **ACQUIRING PROCEEDS FROM ILLEGAL ACTIVITY, TO WIT: HUMAN TRAFFICKING FOR COMMERCIAL SEX**, was feloniously committed by **ANDERSON WALKER, BRANDI MCDANIELS**, and **LESLIE BROWN**, who knowingly acquired proceeds, knowing those proceeds were derived from a violation of the Oklahoma Statutes, to wit: Human Trafficking for Commercial Sex, and knowingly engaged in transactions involving those proceeds, contrary to the provisions of Section 2001(A) of Title 21 and against the peace and dignity of the State of Oklahoma.
