COUNT 1: VOTING ILLEGALLY, 26 O.S. § 16-102, a FELONY

IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OKLAHOMA:

By the order of the Supreme Court of Oklahoma, the Twenty-First Multicounty Grand Jury was convened with its principal site to be in Oklahoma City, Oklahoma County, Oklahoma, to serve from December 16, 2024, for eighteen (18) months, or until the designated presiding judge determines the Twenty-First Multicounty Grand Jury has reached reasonable completion of its investigations, but, in any event, no more than twenty-four (24) months from the commencement of its term. That said Multicounty Grand Jury of the State of Oklahoma, being composed of good and lawful men and woman, legally drawn and summoned according to law, and then and there examined, impaneled, sworn, and charged according to law to diligently inquire into, and true presentment make, of all public offenses against the State of Oklahoma committed and triable within the State of Oklahoma, upon their oath, and in the name and by the authority of the State of Oklahoma, do present and find:

COUNT 1: VOTING ILLEGALLY, 26 O.S. § 16-102, a FELONY

On or about November 5, 2024, in Payne County, Oklahoma, **VICTORIA VINCENZA DILL** committed the crime of **VOTING ILLEGALLY**, a Felony, by willfully voting more than once in the November 2024 General Election, contrary to the provisions of Title 26 O.S. 16-102 and against the peace and dignity of the State of Oklahoma.
