**FOR:**

**COUNT 1: CONSPIRACY TO COMMIT HUMAN TRAFFICKING FOR  
COMMERICAL SEX ~ 21 O.S. § 421, a FELONY.**

**COUNT 2: HUMAN TRAFFICKING FOR COMMERICAL SEX ~ 21 O.S. § 748(A)(6),  
a FELONY.**

*IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OKLAHOMA:*

By the order of the Supreme Court of Oklahoma, the Twenty-First Multi-County Grand Jury of Oklahoma was convened with its principal site to be in Oklahoma City, Oklahoma County, Oklahoma, to serve from December 16, 2024, for eighteen (18) months, or until the designated presiding judge determines the Twenty-First Multi-County Grand Jury has reached reasonable completion of its investigations, but, in any event, no more than twenty-four (24) months from the commencement of its term. That said Multi-County Grand Jury of the State of Oklahoma, being composed of good and lawful men and women, legally drawn and summoned according to law, and then and there examined, impaneled, sworn, and charged according to law to diligently inquire

into, and true presentment make, of all public offenses against the State of Oklahoma committed within the State of Oklahoma, upon their oath, and in the name and by the authority of the State of Oklahoma, do present and find:

**COUNT 1: CONSPIRACY TO COMMIT HUMAN TRAFFICKING FOR COMMERCIAL SEX ~ 21 O.S. § 421, a FELONY**

On or about or between October 30, 2025 and January 7, 2026, the crime of **CONSPIRACY TO COMMIT HUMAN TRAFFICKING FOR COMMERCIAL SEX**, was feloniously committed in Oklahoma County, Oklahoma, by **ALAZE GRANT** and **DANASIA TURNER**, who conspired with one another, to knowingly recruit, entice, harbor, maintain, transport, provide and/or obtain another person, to wit: I.R., through deception, force, fraud, threat, and/or coercion for the purpose of engaging I.R. in commercial sex, acts which were in violation of Section 748(A)(6) of Title 21, in a conspiracy that was contrary to the provisions of Section 421 of Title 21 and against the peace and dignity of the State of Oklahoma.

In furtherance of their conspiracy, a member or members of the conspiracy did commit one or more of the following overt acts:

- a. On or about October 30, 2025, **DANASIA TURNER** invited I.R. to the Platinum Nights Gentleman's Club, located at 7700 W.P. Bill Atkinson Blvd., Oklahoma City, Oklahoma 73134, for the purpose of seeing if I.R. would be interested in dancing or stripping.
- b. On or about or between December 23, 2025, **DANASIA TURNER** paid for an Uber for I.R. to come to her apartment, located at 1105 ½ S.W. 74<sup>th</sup> Street, Apt. 1111-2, Oklahoma City, Oklahoma 73139.

- c. On or about or between October 30, 2025, and January 7, 2026, **DANASIA TURNER** and **ALAZE GRANT**, made I.R. rent a vehicle to drive **DANASIA TURNER** and I.R. to perform commercial sex dates.
- d. On or about or between October 30, 2025, and January 7, 2026, I.R. witnessed **DANASIA TURNER** provide money derived from commercial sex dates to **ALAZE GRANT**.
- e. On or about or between October 30, 2025, and January 7, 2026, **ALAZE GRANT** and **DANASIA TURNER**, monitored I.R.'s phone usage to ensure she was using it to "make money."
- f. On or about or between October 30, 2025, and January 7, 2026, **ALAZE GRANT** and **DANASIA TURNER**, made I.R. set up accounts on various websites used for advertising commercial sex.
- g. On or about or between October 30, 2025, and January 7, 2026, **ALAZE GRANT** and **DANASIA TURNER**, threatened I.R. with physical harm if she did not comply with the "rules" and do what **ALAZE GRANT** expected of her.


**COUNT 2: HUMAN TRAFFICKING FOR COMMERCIAL SEX ~ 21 O.S. § 748(A)(6) a FELONY**

On or about or between December 23, 2025, and January 7, 2026, the crime of **HUMAN TRAFFICKING FOR COMMERCIAL SEX** was feloniously committed in Oklahoma County, Oklahoma, by **ALAZE DASHAUN GRANT** and **DANASIA SHENAE TURNER**, who knowingly recruited, enticed, harbored, maintained, transported, provided, and/or obtained another person, to wit: I.R., through deception, force, fraud, threat, and/or coercion for purposes of engaging I.R. in a commercial sex act or acts with third parties, contrary to the provisions of Section 748(A)(6) of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.
