INDICTMENT

*IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OKLAHOMA:*

By the order of the Supreme Court of Oklahoma, the Twenty-First Multicounty Grand Jury was convened with its principal site to be in Oklahoma City, Oklahoma County, Oklahoma, to serve from December 16, 2024, for eighteen (18) months, or until the designated presiding judge determines the Twenty-First Multicounty Grand Jury has reached reasonable completion of its investigations, but, in any event, no more than twenty-four (24) months from the commencement of its term. That said Multicounty Grand Jury of the State of Oklahoma, being composed of good and lawful men and woman, legally drawn and summoned according to law, and then and there examined, impaneled, sworn, and charged according to law to diligently inquire into, and true presentment make, of all public offenses against the State of Oklahoma committed and triable within the State of Oklahoma, upon their oath, and in the name and by the authority of the State of Oklahoma, do present and find:

**COUNT 1: FALSE PERSONATION OF A PUBLIC OFFICER, 21 O.S. § 1533, a MISDEMEANOR**

On or about August 26, 2024, **OWEN THOMAS CUNNINGHAM** committed the crime of **FALSE PERSONATION OF A PUBLIC OFFICER**, a misdemeanor, in Oklahoma County, Oklahoma, by falsely assuming the identity of Ryan Walters, a public officer, and in that assumed character directed Oklahoma School Superintendents to distribute documents to public school classrooms, an act which harassed, vexed, or annoyed Ryan Walters and/or the School Superintendents, contrary to the provisions of Section 1533 of Title 21 of the Oklahoma Statutes and against the peace and dignity of the State of Oklahoma.
