**COUNT 2: ACQUIRING PROCEEDS FROM ILLEGAL ACTIVITY, TO WIT: HUMAN TRAFFICKING FOR COMMERCIAL SEX ~ 21 O.S. § 2001(A), a FELONY**

**COUNT 3: POSSESSING CONTRABAND IN A PENAL INSTITUTION TO WIT: A CELLPHONE ~ 57 O.S. § 21(E), a FELONY**

*IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OKLAHOMA:*

By the order of the Supreme Court of Oklahoma, the Twenty-First Multi-County Grand Jury of Oklahoma was convened with its principal site to be in Oklahoma City, Oklahoma County, Oklahoma, to serve from December 16, 2024, for eighteen (18) months, or until the designated presiding judge determines the Twenty-First Multi-County Grand Jury has reached reasonable completion of its investigations, but, in any event, no more than twenty-four (24) months from the commencement of its term. That said Multi-County Grand Jury of the State of Oklahoma, being composed of good and lawful men and women, legally drawn and summoned according to law,

and then and there examined, impaneled, sworn, and charged according to law to diligently inquire into, and true presentment make, of all public offenses against the State of Oklahoma committed within the State of Oklahoma, upon their oath, and in the name and by the authority of the State of Oklahoma, do present and find:

**COUNT 1: HUMAN TRAFFICKING FOR COMMERCIAL SEX ~ 21 O.S. § 748(A)(6), a FELONY**


On or about or between November 1, 2024, and September 1, 2025, in Oklahoma County, Cleveland County, Pontotoc County, and Atoka County, the crime of **HUMAN TRAFFICKING FOR COMMERCIAL SEX**, was feloniously committed by **CHARQUION DERAÉ POPE**, who knowingly recruited, enticed, harbored, maintained, transported, provided and/or obtained another person, to wit:, A.S., through deception, force, fraud, threat, and/or coercion for the purpose of engaging A.S. in commercial sex, contrary to the provisions of Section 748(A)(6) of Title 21 and against the peace and dignity of the State of Oklahoma.

FELONY**


On or about or between November 1, 2024, and September 1, 2025, in Oklahoma County, Cleveland County, Pontotoc County, and Atoka County, the crime of **ACQUIRING PROCEEDS FROM ILLEGAL ACTIVITY, TO WIT: HUMAN TRAFFICKING FOR COMMERCIAL SEX**, was feloniously committed by **CHARQUION DERAЕ POPE**, who knowingly acquired proceeds, knowing those proceeds were derived from a violation of the Oklahoma Statutes, to wit: Human Trafficking for Commercial Sex, and knowingly engaged in transactions involving those proceeds, contrary to the provisions of Section 2001(A) of Title 21 and against the peace and dignity of the State of Oklahoma.

**COUNT 3: POSSESSING CONTRABAND IN A PENAL INSTITUTION, TO WIT: A CELLPHONE ~ 57 O.S. § 21(E), a FELONY**


On or about April 8, 2025, in Atoka County, the crime of **POSSESSING CONTRABAND IN A PENAL INSTITUTION, TO WIT: A CELLPHONE**, was feloniously committed by **CHARQUION DERAÉ POPE**, who without authority, had possession of a cellphone, an electronic device, inside Mack Alford Correctional Center, located at 13001 North US-69, Atoka, Oklahoma 74525, a penal institution, contrary to the provisions of Section 21(E) of Title 57 and against the peace and dignity of the State of Oklahoma.

**COUNT 4: ENGAGING IN A PATTERN OF CRIMINAL OFFENSES ~ 21 O.S. § 425, a FELONY**

On or about or between November 1, 2024, and September 1, 2025, the crime of **ENGAGING IN A PATTERN OF CRIMINAL OFFENSES** was feloniously committed by **CHARQUION DERAË POPE** by perpetrating criminal offenses – including the crimes of Human Trafficking for Commercial Sex, Acquiring Proceeds from Illegal Activity, and Possessing Contraband in a Penal Institution, to wit: a cellphone – in two or more counties in the State of Oklahoma, with said offenses occurring in Oklahoma County, Cleveland County, Pontotoc County, and Atoka County, with such offenses being committed as part of the same plan, scheme, or adventure. Such pattern of offenses included acts which occurred at 13001 North US-69, Atoka, Oklahoma 74525; 16116 Montague Drive, Edmond, Oklahoma 73013; 802 N.W. 12<sup>th</sup> Street, Apt. 3, Moore, Oklahoma 73160; and 1000 E. 18<sup>th</sup> Street, Ada, Oklahoma 74820. These acts constituted a pattern of criminal offenses contrary to the provisions of Section 425 of Title 21 of the Oklahoma Statutes and against the peace and dignity of the State of Oklahoma.


