**COUNT 1: CONSPIRACY TO COMMIT HUMAN TRAFFICKING FOR
COMMERICAL SEX ~ 21 O.S. § 421, a FELONY.**

**COUNT 2: HUMAN TRAFFICKING FOR COMMERICAL SEX ~ 21 O.S. § 748(A)(6),
a FELONY.**

IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OKLAHOMA:

By the order of the Supreme Court of Oklahoma, the Twenty-Second Multi-County Grand Jury of Oklahoma was convened with its principal site to be in Oklahoma City, Oklahoma County, Oklahoma, to serve from June 15, 2026, for eighteen (18) months, or until the designated presiding judge determines the Twenty-First Multi-County Grand Jury has reached reasonable completion of its investigations, but, in any event, no more than twenty-four (24) months from the commencement of its term. That said Multi-County Grand Jury of the State of Oklahoma, being composed of good and lawful men and women, legally drawn and summoned according to law,

and then and there examined, impaneled, sworn, and charged according to law to diligently inquire into, and true presentment make, of all public offenses against the State of Oklahoma committed within the State of Oklahoma, upon their oath, and in the name and by the authority of the State of Oklahoma, do present and find:

COUNT 1: CONSPIRACY TO COMMIT HUMAN TRAFFICKING FOR COMMERCIAL SEX ~ 21 O.S. § 421, a FELONY

On or about or between June 20, 2026 and June 27, 2026, the crime of **CONSPIRACY TO COMMIT HUMAN TRAFFICKING FOR COMMERCIAL SEX**, was feloniously committed in Oklahoma County, Oklahoma, by **MICHAEL LYNNTAY DAVIS** and **MARIA FERNANDA CONTRERAS ROSALES**, who conspired with one another, to knowingly recruit, entice, harbor, maintain, transport, provide and/or obtain another person, to wit: M.D., through deception, force, fraud, threat, and/or coercion for the purpose of engaging M.D. in commercial sex, acts which were in violation of Section 748(A)(6) of Title 21, in a conspiracy that was contrary to the provisions of Section 421 of Title 21 and against the peace and dignity of the State of Oklahoma.

In furtherance of their conspiracy, a member or members of the conspiracy did commit one or more of the following overt acts:

- a. On or about June 20, 2026, **MARIA FERNANDA CONTRERAS ROSALES** invited M.D. to her apartment, located at 3333 SW 51st Street, Oklahoma City, Oklahoma 73119, for the purpose of having a party and seeing if M.D. would be interested performing commercial sex dates.
- b. On or about or between June 20, 2026, **MICHAEL LYNNTAY DAVIS** and **MARIA FERNANDA CONTRERAS ROSALES**, took photographs of M.D. and asked M.D.

to send photographs to them, for the purpose of creating a commercial sex advertisement on MegaPersonals.com.

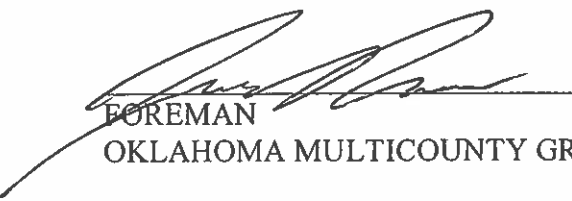
- c. On or about or between June 20, 2026, and June 27, 2026, **MICHAEL LYNNTAY DAVIS** and **MARIA FERNANDA CONTRERAS ROSALES** arranged commercial sex dates for M.D. at a local hotel, at their apartment, or in vehicles.
- d. On or about or between June 20, 2026, and June 27, 2026, **MICHAEL LYNNTAY DAVIS** and **MARIA FERNANDA CONTRERAS ROSALES** drove M.D. to various commercial sex dates to perform commercial sex.
- e. On or about or between June 20, 2026, and June 27, 2026, **MICHAEL LYNNTAY DAVIS** and **MARIA FERNANDA CONTRERAS ROSALES** arranged the type of dates, what time the date would occur, how long the date was for, and how much money would be collected. **MICHAEL LYNNTAY DAVIS** collected all of the money M.D. made from performing commercial sex dates.

COUNT 2: HUMAN TRAFFICKING FOR COMMERCIAL SEX ~ 21 O.S. § 748(A)(6) a FELONY

On or about or between June 20, 2026, and June 27, 2026, the crime of **HUMAN TRAFFICKING FOR COMMERCIAL SEX** was feloniously committed in Oklahoma County, Oklahoma, by **MICHAEL LYNNTAY DAVIS** and **MARIA FERNANDA CONTRERAS ROSALES**, who knowingly recruited, enticed, harbored, maintained, transported, provided, and/or obtained another person, to wit: M.D., through deception, force, fraud, threat, and/or coercion for purposes of engaging M.D. in a commercial sex act or acts with third parties, contrary to the provisions of Section 748(A)(6) of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

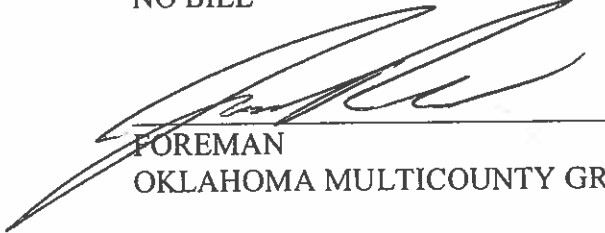
