INFORMATION

**BE IT REMEMBERED:**

That Gentner Drummond, the duly elected and qualified Attorney General for the State of Oklahoma, and Stephen A. Kunzweiler, the duly elected and qualified District Attorney for Tulsa County, Oklahoma, who prosecutes in the name and by the authority of the State of Oklahoma, come now into the District Court of Tulsa County, State of Oklahoma, and give the Court to understand and be informed that:

(COUNT 1)

21 O.S. § 424

On or about or between the 5th day of February, 2019, and 9th day of September, 2024, the crime of Conspiracy to Defraud a School District was feloniously committed in Tulsa County, Oklahoma, by CHARLES HUDGINS, GAYLE GWINUP, and THOMAS MCKENNA, who acting jointly, entered into an agreement to defraud Tulsa Public Schools, and in furtherance of their conspiracy, a member or members of the conspiracy did one or more of the following overt acts: Charles Hudgins, as Executive Director of Tulsa Public School's Bond Department, assigned Gayle Gwinup and Thomas McKenna's limited liability company, Allied Engineering Group, to do engineering work on roofing projects at various schools, when no engineering work was needed to be performed; Gayle Gwinup and/or Thomas McKenna submitted invoices on behalf of Allied Engineering Group, for work which was not performed on the roofing projects; Charles Hudgins approved for payment the invoices submitted from Allied Engineering Group; Gayle Gwinup and/or Thomas McKenna on behalf of Allied Engineering Group funneled a majority of those funds to Charles Hudgins' company, M & G Consulting, for work which was not performed; contrary to the provisions of 21 O.S. 424 of the Oklahoma statutes, and against the peace and dignity of the State of Oklahoma.

**(COUNT 2)**  
**19 O.S. § 641**

On or about or between the 5th day of February, 2019, and 15th day of February, 2019, the crime of **Embezzlement** was feloniously committed in Tulsa County, Oklahoma, by **CHARLES HUDGINS, GAYLE GWINUP, and THOMAS MCKENNA**, who acting jointly, while Charles Hudgins, as Executive Director of Tulsa Public School's Bond Department, was a person charged with collection, receipt, safekeeping, transfer or disbursement of public money belonging to Tulsa Public Schools, a school district of the state, did unlawfully convert said money to the use of Charles Hudgins, Gayle Gwinup, Thomas McKenna, M & G Consulting Services LLC, Allied Engineering Group LLC, and/or Starr Design Group Inc., to wit: Gayle Gwinup and/or Thomas McKenna submitting an invoice on behalf of their limited liability company, Allied Engineering Group, for work which was not performed on the roofing project at Unity Learning Academy, which Charles Hudgins approved for payment, and then Allied Engineering Group funneled a majority of those funds to Charles Hudgins' company, M & G Consulting, for work which was also not performed, contrary to the provisions of 19 O.S. 641 of the Oklahoma statutes, and against the peace and dignity of the State of Oklahoma.

**(COUNT 3)**  
**19 O.S. § 641**

On or about or between the 5th day of February, 2019, and 15th day of February, 2019, the crime of **Embezzlement** was feloniously committed in Tulsa County, Oklahoma, by **CHARLES HUDGINS, GAYLE GWINUP, and THOMAS MCKENNA**, who acting jointly, while Charles Hudgins, as Executive Director of Tulsa Public School's Bond Department, was a person charged with collection, receipt, safekeeping, transfer or disbursement of public money belonging to Tulsa Public Schools, a school district of the state, did unlawfully convert said money to the use of Charles Hudgins, Gayle Gwinup, Thomas McKenna, M & G Consulting Services LLC, Allied Engineering Group LLC, and/or Starr Design Group Inc., to wit: Gayle Gwinup and/or Thomas McKenna submitting an invoice on behalf of their limited liability company, Allied Engineering Group, for work which was not performed on the roofing project at Mark Twain Elementary School, which Charles Hudgins approved for payment, and then Allied Engineering Group funneled a majority of those funds to Charles Hudgins' company, M & G Consulting, for work which was also not performed, contrary to the provisions of 19 O.S. 641 of the Oklahoma statutes, and against the peace and dignity of the State of Oklahoma.

On or about or between the 6th day of March, 2019, and the 15th day of March, 2019, the crime of **Embezzlement** was feloniously committed in Tulsa County, Oklahoma, by **CHARLES HUDGINS, GAYLE GWINUP, and THOMAS MCKENNA**, who acting jointly, while Charles Hudgins, as Executive Director of Tulsa Public School's Bond Department, was a person charged with collection, receipt, safekeeping, transfer or disbursement of public money belonging to Tulsa Public Schools, a school district of the state, did unlawfully convert said money to the use of Charles Hudgins, Gayle Gwinup, Thomas McKenna, M & G Consulting Services LLC, Allied Engineering Group LLC, and/or Starr Design Group Inc., to wit: Gayle Gwinup and/or Thomas McKenna submitting an invoice on behalf of their limited liability company, Allied Engineering Group, for work which was not performed on the roofing project at Monroe Demonstration Academy, which Charles Hudgins approved for payment, and then Allied Engineering Group funneled a majority of those funds to Charles Hudgins' company, M & G Consulting, for work which was also not performed, contrary to the provisions of 19 O.S. 641 of the Oklahoma statutes, and against the peace and dignity of the State of Oklahoma.

On or about or between the 20th day of May, 2022, and the 29th day of September, 2022, the crime of **Embezzlement** was feloniously committed in Tulsa County, Oklahoma, by **CHARLES HUDGINS, GAYLE GWINUP, and THOMAS MCKENNA**, who acting jointly, while Charles Hudgins, as Executive Director of Tulsa Public School's Bond Department, was a person charged with collection, receipt, safekeeping, transfer or disbursement of public money belonging to Tulsa Public Schools, a school district of the state, did unlawfully convert said money to the use of Charles Hudgins, Gayle Gwinup, Thomas McKenna, M & G Consulting Services LLC, Allied Engineering Group LLC, and/or Starr Design Group Inc., to wit: Gayle Gwinup and/or Thomas McKenna submitting an invoice on behalf of their limited liability company, Allied Engineering Group, for work which was not performed on the roofing project at Eliot Elementary School, Skelly Elementary School, Street School, and Roof Maintenance Repairs, which Charles Hudgins approved for payment, and then Allied Engineering Group funneled a majority of those funds to Charles Hudgins' company, M & G Consulting, for work which was also not performed, contrary to the provisions of 19 O.S. 641 of the Oklahoma statutes, and against the peace and dignity of the State of Oklahoma.

On or about or between the 8th day of August, 2024, and the 3rd day of September, 2024, the crime of **Embezzlement** was feloniously committed in Tulsa County, Oklahoma, by **CHARLES HUDGINS** and **THOMAS MCKENNA**, who acting jointly, while Charles Hudgins, as Executive Director of Tulsa Public School's Bond Department, was a person charged with collection, receipt, safekeeping, transfer or disbursement of public money belonging to Tulsa Public Schools, a school district of the state, did unlawfully convert said money to the use of Charles Hudgins, Thomas McKenna, M & G Consulting Services LLC, Starr Design Group Inc., to wit: Thomas McKenna submitting an invoice on behalf of his corporation, Starr Design Group, for work which was not performed on the roofing project at Carver Middle School, which Charles Hudgins approved for payment, and then Starr Design Group funneled a majority of those funds to Charles Hudgins' company, M & G Consulting, for work which was also not performed, contrary to the provisions of 19 O.S. 641 of the Oklahoma statutes, and against the peace and dignity of the State of Oklahoma.

**(COUNT 17)**

**19 O.S. § 641**

On or about or between the 8th day of August, 2024, and the 9th day of September, 2024, the crime of **Embezzlement** was feloniously committed in Tulsa County, Oklahoma, by **CHARLES HUDGINS** and **THOMAS MCKENNA**, who acting jointly, while Charles Hudgins, as Executive Director of Tulsa Public School's Bond Department, was a person charged with collection, receipt, safekeeping, transfer or disbursement of public money belonging to Tulsa Public Schools, a school district of the state, did unlawfully convert said money to the use of Charles Hudgins, Thomas McKenna, M & G Consulting Services LLC, Starr Design Group Inc., to wit: Thomas McKenna submitting an invoice on behalf of his corporation, Starr Design Group, for work which was not performed on the roofing project at Phoenix Rising Alternative School, which Charles Hudgins approved for payment, and then Starr Design Group funneled a majority of those funds to Charles Hudgins' company, M & G Consulting, for work which was also not performed, contrary to the provisions of 19 O.S. 641 of the Oklahoma statutes, and against the peace and dignity of the State of Oklahoma.

**(COUNT 18)**

**74 O.S. 3402-3404**

On or about or between the 20th day of September, 2023, and the 26th day of October, 2023, the crime of **Making a Kickback** was feloniously and jointly committed in Tulsa County, Oklahoma, by **GAYLE GWINUP** and **THOMAS MCKENNA**, who while holding a contract with Tulsa Public Schools for the furnishing of goods or services for Eisenhower International School via their companies - Allied Engineering Group LLC, and/or Starr Design Group Inc., did unlawfully give money to Charles Hudgins, the Executive Director of Tulsa Public School's Bond Department, and to Hudgins' company - M & G Consulting Services LLC, for the purpose of acquiring or holding such contract with Tulsa Public Schools, contrary to the provisions of 74 O.S. 3402-3404 of the Oklahoma statutes, and against the peace and dignity of the State of Oklahoma.

**(COUNT 19)**

**74 O.S. 3402-3404**

On or about or between the 20th day of September, 2023, and the 26th day of October, 2023, the crime of **Receiving a Kickback** was feloniously committed in Tulsa County, Oklahoma, by **CHARLES HUDGINS**, the Executive Director of Tulsa Public School's Bond Department, who unlawfully received money from Gayle Gwinup, Thomas McKenna, Allied Engineering Group LLC, and/or Starr Design Group Inc., who held a contract with Tulsa Public Schools for the furnishing of goods or services for Eisenhower International School, said money being paid to Charles Hudgins and his company - M & G Consulting Services LLC, for the purpose of acquiring or holding such contract with Tulsa Public Schools, contrary to the provisions of 74 O.S. 3402-3404 of the Oklahoma statutes, and against the peace and dignity of the State of Oklahoma.

**(COUNT 20)**

**74 O.S. 3402-3404**

On or about or between the 13th day of October, 2023, and the 9th day of November, 2023, the crime of **Making a Kickback** was feloniously and jointly committed in Tulsa County, Oklahoma, by **GAYLE GWINUP** and **THOMAS MCKENNA**, who while holding a contract with Tulsa Public Schools for the furnishing of goods or services for Webster Middle and High School via their companies - Allied Engineering Group LLC, and/or Starr Design Group Inc., did unlawfully give money to Charles Hudgins, the Executive Director of Tulsa Public School's Bond Department, and to Hudgins' company - M & G Consulting Services LLC, for the purpose of acquiring or holding such contract with Tulsa Public Schools, contrary to the provisions of 74 O.S. 3402-3404 of the Oklahoma statutes, and against the peace and dignity of the State of Oklahoma.

**(COUNT 21)**

**74 O.S. 3402-3404**

On or about or between the 13th day of October, 2023, and the 9th day of November, 2023, the crime of **Receiving a Kickback** was feloniously committed in Tulsa County, Oklahoma, by **CHARLES HUDGINS**, the Executive Director of Tulsa Public School's Bond Department, who unlawfully received money from Gayle Gwinup, Thomas McKenna, Allied Engineering Group LLC, and/or Starr Design Group Inc., who held a contract with Tulsa Public Schools for

the furnishing of goods or services for Webster Middle and High School, said money being paid to Charles Hudgins and his company - M & G Consulting Services LLC, for the purpose of acquiring or holding such contract with Tulsa Public Schools, contrary to the provisions of 74 O.S. 3402-3404 of the Oklahoma statutes, and against the peace and dignity of the State of Oklahoma.

**(COUNT 22)**

**74 O.S. 3402-3404**


