On or between June 25, 2025, and September 13, 2025, in Tulsa County, State of Oklahoma, the crime of **HUMAN TRAFFICKING OF A MINOR FOR COMMERCIAL SEX**, a Felony, was committed by **JIRAY JIVAR CLAY**, who knowingly recruited, enticed, harbored, maintained, transported, provided and/or obtained minor, to wit: Z.A., for the purpose of engaging Z.A. in commercial sex, contrary to the provisions of Section 748(A)(6)(b) of Title 21 and against the peace and dignity of the State of Oklahoma.

COUNT 3: SOLICITATION OF A MINOR, a FELONY~ 21 O.S. § 1021(B)(1)

On or between August 7, 2025, and August 9, 2025, in Tulsa County, State of Oklahoma, the crime of **SOLICITATION OF A MINOR**, a Felony, was committed by **JIRAY JAVAR CLAY**, by willfully soliciting/aiding a minor child to photograph/distribute child sexual abuse material, to wit: Defendant sent a sexually explicit photograph to minor child Z.A., instructing her via text message to “take photos like this”, contrary to the provisions of Section 1021(B)(1) and against the peace and dignity of the State of Oklahoma.

On or between August 23, 2025, and September 13, 2025, in Tulsa County, State of Oklahoma, the crime of **DISTRIBUTION OF CHILD SEXUAL ABUSE MATERIAL**, a Felony, was committed by **JIRAY JIVAR CLAY**, who willfully published and/or distributed child sexual abuse material, to wit: Defendant used sexually explicit/nude photos and/or videos of K.S., a minor child, depicting child sexual abuse material in online ads for commercial sex and/or disseminated through text messages photos and/or videos of K.S., a minor child, depicting child sexual abuse material, contrary to the provisions of Section 1021(A)(3) of Title 21 and against the peace and dignity of the State of Oklahoma.

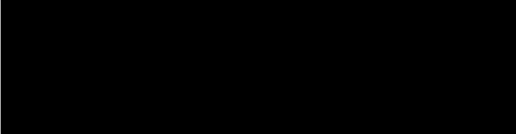

On or between June 25, 2025, and November 13, 2025, in Tulsa County, State of Oklahoma, the crime of **USING A COMPUTER TO VIOLATE OKLAHOMA STATUTES**, a Felony, was committed by **JIRAY JIVAR CLAY**, by knowingly using a computer system, to wit: a cell phone, to violate the Oklahoma Computer Crimes Act, contrary to the provisions of Section 1958 of Title 21 and against the peace and dignity of the State of Oklahoma.

AS CHARGED IN THE INDICTMENT IN THIS CASE WERE COMMITTED BY THE DEFENDANT, **JIRAY JIVAR CLAY**, NAMED THEREIN, AFTER HAVING PREVIOUSLY BEEN CONVICTED OF THE FOLLOWING CRIME PUNISHABLE BY IMPRISONMENT:

*That the said **JIRAY JAVAR CLAY** was heretofore on 7/08/21, in TULSA COUNTY, OKLAHOMA, Case No. CF-2021-320, convicted of a Felony, to-wit: the crime of **LARCENY OF MERCHANDISE FROM A RETAILER** and sentenced to a term of 4 years. Said crime being an offense punishable under the laws of this state by imprisonment in the penitentiary. Said defendant being represented by counsel at the time, and said conviction being a final judgment in the case.*
