INDICTMENT

IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OKLAHOMA:

By the order of the Supreme Court of Oklahoma, the Twenty-Second Multi-County Grand Jury of Oklahoma was convened with its principal site to be in Oklahoma City, Oklahoma County, Oklahoma, to serve from June 15, 2026, for eighteen (18) months, or until the designated presiding judge determines the Twenty-Second Multi-County Grand Jury has reached reasonable completion of its investigations, but, in any event, no more than twenty-four (24) months from the commencement of its term. That said Multi-County Grand Jury of the State of Oklahoma, being composed of good and lawful men and women, legally drawn and summoned according to law, and then and there examined, impaneled, sworn, and charged according to law to diligently inquire into, and true presentment make, of all public offenses against the State of Oklahoma committed within the State of Oklahoma, upon their oath, and in the name and by the authority of the State of Oklahoma, do present and find:

**COUNT 1: HUMAN TRAFFICKING FOR COMMERCIAL SEX ~ 21 O.S. § 748(A)(6) a
FELONY**

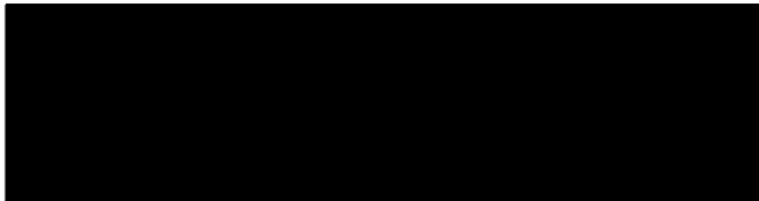
On or about or between January 1, 2019, and September 3, 2026, the crime of **HUMAN TRAFFICKING FOR COMMERCIAL SEX** was feloniously committed in Oklahoma County, Oklahoma, by **LI MENG**, who knowingly recruited, enticed, harbored, maintained, transported, provided, and/or obtained another person, to wit: C.W., through deception, force, fraud, threat, and/or coercion for purposes of engaging C.W. in commercial sex and knowingly benefiting from said activity by setting the location, that being Natural Massage, 2903 NW 36th Street, Suite 109, Oklahoma City, Oklahoma 73112, at which C.W. would engage in an act of prostitution with a third party, and/or setting the place at which C.W. would reside for purposes of making C.W. available to engage in an act of prostitution with a third party, contrary to the provisions of Section 748(A)(6) of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

**COUNT 2: HUMAN TRAFFICKING FOR COMMERCIAL SEX ~ 21 O.S. § 748(A)(6) a
FELONY**

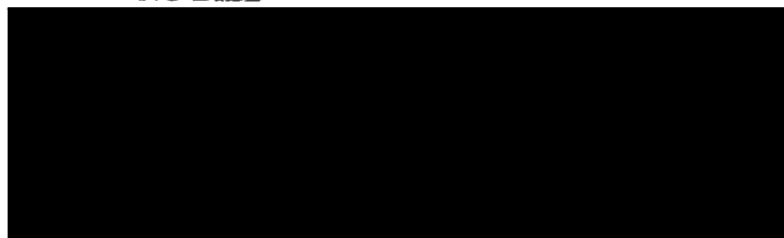
On or about or between December 1, 2019, and September 3, 2026, the crime of **HUMAN TRAFFICKING FOR COMMERCIAL SEX** was feloniously committed in Oklahoma County, _____ Oklahoma, by **LI MENG**, who knowingly recruited, enticed, harbored, maintained, transported, provided, and/or obtained another person, to wit: Y.L., through deception, force, fraud, threat, and/or coercion for purposes of engaging Y.L. in commercial sex and knowingly benefiting from said activity by setting the location, that being Dreams of Realizing, 8505 S. Pennsylvania Ave. Oklahoma City, Oklahoma 73159, at which Y.L. would engage in an act of prostitution with a third party, and/or setting the place at which Y.L. would reside for purposes of making Y.L. available to engage in an act of prostitution with a third party, contrary to the provisions of Section 748(A)(6) of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

HUMAN TRAFFICKING FOR COMMERCIAL SEX ~ 21 O.S. § 2001(A), a
FELONY**

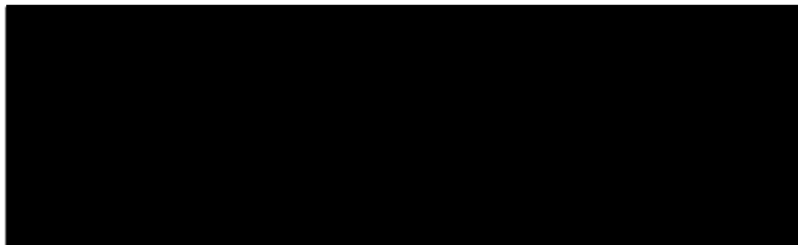
On or about or between January 1, 2019, and September 3, 2026, the crime of
**ACQUIRING PROCEEDS FROM ILLEGAL ACTIVITY, TO WIT: HUMAN
TRAFFICKING FOR COMMERCIAL SEX** was feloniously committed in Oklahoma County,
Oklahoma, by **LI MENG**, who knowingly acquired proceeds, knowing those proceeds were
derived from a violation of the Oklahoma Statutes, to wit: Human Trafficking for Commercial
Sex, and knowingly engaged in transactions involving those proceeds, contrary to the provisions
of Section 2001(A) of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the
State of Oklahoma.
