INDICTMENT

IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OKLAHOMA:

By the order of the Supreme Court of Oklahoma, the Twenty-Second Multi-County Grand Jury of Oklahoma was convened with its principal site to be in Oklahoma City, Oklahoma County, Oklahoma, to serve from June 15, 2026, for eighteen (18) months, or until the designated presiding judge determines the Twenty-First Multi-County Grand Jury has reached reasonable completion of its investigations, but, in any event, no more than twenty-four (24) months from the commencement of its term. That said Multi-County Grand Jury of the State of Oklahoma, being composed of good and lawful men and women, legally drawn and summoned according to law, and then and there examined, impaneled, sworn, and charged according to law to diligently inquire into, and true presentment make, of all public offenses against the State of Oklahoma committed within the State of Oklahoma, upon their oath, and in the name and by the authority of the State of Oklahoma, do present and find:

**COUNT 1: HUMAN TRAFFICKING OF A MINOR FOR COMMERICAL SEX ~ 21
O.S. § 748(A)(6)(b), a FELONY.**

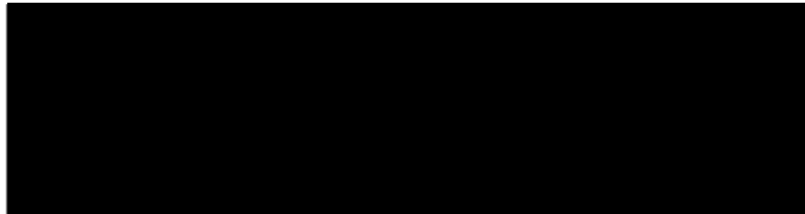
On or about or between January 1, 2019, and December 31, 2022, the crime of **HUMAN TRAFFICKING OF A MINOR FOR COMMERICAL SEX** was feloniously committed in Oklahoma County, Oklahoma, by **LORRIE LYNN KENNEDY**, who knowingly recruited, enticed, harbored, maintained, transported, provided, and/or obtained a minor, to wit: W.G., whom at the time was between the ages of 10 and 12 years old, for the purpose of engaging W.G. in an act or acts of commercial sex, contrary to the provisions of Section 748(A)(6)(b) of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

**COUNT 2: HUMAN TRAFFICKING OF A MINOR FOR COMMERICAL SEX ~ 21
O.S. § 748(A)(6)(b), a FELONY.**

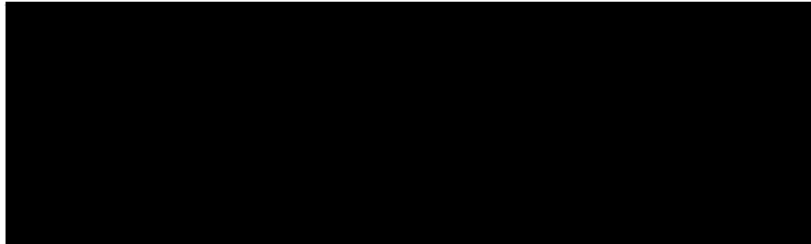
On or about or between January 1, 2016, and December 31, 2022, the crime of **HUMAN TRAFFICKING OF A MINOR FOR COMMERICAL SEX** was feloniously committed in Oklahoma County, Oklahoma, by **LORRIE LYNN KENNEDY**, who knowingly recruited, enticed, harbored, maintained, transported, provided, and/or obtained a minor, to wit: M.G., whom at the time was between the ages of 4 and 9 years old, for the purpose of engaging M.G. in an act or acts of commercial sex, contrary to the provisions of Section 748(A)(6)(b) of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

COUNT 3: CHILD SEXUAL EXPLOITATION ~ 21 O.S. § 843.5(I), a FELONY.

On or about or between January 1, 2019, and December 31, 2022, the crime of **CHILD SEXUAL EXPLOITATION** was feloniously committed in Oklahoma County, Oklahoma, by **LORRIE LYNN KENNEDY**, who willfully and/or maliciously exploited W.G., a child under the age of eighteen, by committing an enumerated exploitation offense, to wit: Human Trafficking of a Minor for Commercial Sex, contrary to the provisions of Section 843.5(I) of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma.

COUNT 4: CHILD SEXUAL EXPLOITATION ~ 21 O.S. § 843.5(I), a FELONY.

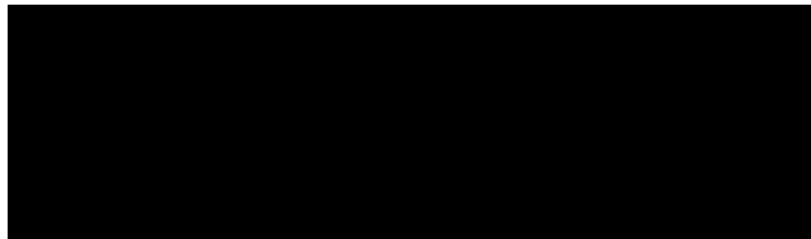

COUNT 5: CHILD NEGLECT ~ 21 O.S. § 843.5(C), a FELONY.

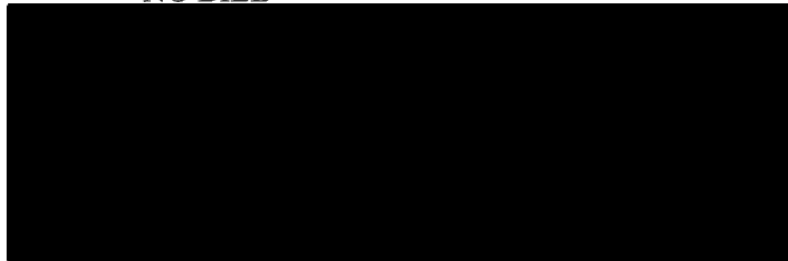
On or about or between January 1, 2016, and December 31, 2022, the crime of **CHILD NEGLECT** was feloniously committed in Oklahoma County, Oklahoma, by **LORRIE LYNN KENNEDY**, a person responsible for the health, safety, and welfare of W.G., M.G., and J.G., all children under the age of eighteen, by willfully and/or maliciously, failing to protect W.G., M.G., and J.G., from exposure to the use and/or sale of illegal drugs and/or failing to provide adequate food, contrary to the provisions of Section 843.5(C) of Title 21 of the Oklahoma Statutes, and against the peace and dignity of the State of Oklahoma
