INDICTMENT

HEATHER E. COYLE

IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OKLAHOMA:

By the order of the Supreme Court of Oklahoma, the Twenty-Second Multi-County Grand Jury of Oklahoma was convened with its principal site to be in Oklahoma City, Oklahoma County, Oklahoma, to serve from June 15, 2026, for eighteen (18) months, or until the designated presiding judge determines the Twenty-Second Multi-County Grand Jury has reached reasonable completion of its investigations, but, in any event, no more than twenty-four (24) months from the commencement of its term. That said Multi-County Grand Jury of the State of Oklahoma, being composed of good and lawful men and women, legally drawn and summoned according to law, and then and there examined, impaneled, sworn, and charged according to law to diligently inquire into, and true presentment make, of all public offenses against the State of Oklahoma committed

within the State of Oklahoma, upon their oath, and in the name and by the authority of the State of Oklahoma, do present and find:

**COUNT 1: CONSPIRACY TO COMMIT HUMAN TRAFFICKING FOR
COMMERCIAL SEX ~ 21 O.S. § 421, a FELONY**

On or about or between June 4, 2026, and June 9, 2026, in Oklahoma County and Caddo County, the crime of **CONSPIRACY TO COMMIT HUMAN TRAFFICKING FOR COMMERCIAL SEX**, was feloniously committed by **CALEB RICHEY, PHALESHA BEAN**, and **LEE SUTTER**, who conspired with one another, to knowingly recruit, entice, harbor, maintain, transport, provide and/or obtain another person or persons, to wit: B.M., through deception, force, fraud, threat, and/or coercion for the purpose of engaging B.M. in commercial sex, acts which were in violation of Section 748(A)(6) of Title 21, in a conspiracy that was contrary to the provisions of Section 421 of Title 21 and against the peace and dignity of the State of Oklahoma.

In furtherance of their conspiracy, a member or members of the conspiracy did commit one or more of the following overt acts:

- a. On or about or between June 4, 2026, and June 9, 2026, **CALEB RICHEY** and **PHALESHA BEAN** began posting commercial sex advertisements with B.M.
- b. On or about or between June 4, 2026, and June 9, 2026, **CALEB RICHEY** and **PHALESHA BEAN** began setting up commercial sex dates for B.M. by setting the time, place, and location of the date, as well as dictating the prices for each date.
- c. On or about June 5, 2026, **CALEB RICHEY** instructs B.M. to follow **PHALESHA BEAN's** "lead" and **PHALESHA BEAN** will raise B.M. right.

d. On or about June 6, 2026, **CALEB RICHEY** instructs members of his gang to show up at B.M. house to threaten her. **CALEB RICHEY** is on the phone during the whole altercation.

e. On or about June 6, 2026, **CALEB RICHEY** and **PHALESHA BEAN** discuss **LEE SUTTER** with B.M. and that he is a “regular” john that they send girls to.

f. On or about June 6, 2026, **PHALESHA BEAN** discusses getting money from B.M. in relation to her commercial sex date with **LEE SUTTER**.

g. On or about June 6, 2026, **PHALESHA BEAN** indicates that **CALEB RICHEY** has a Chime account and that B.M. should send her the money through CashApp and then she will send it **CALEB RICHEY**.

h. On or about June 7, 2026, B.M. sends **CALEB RICHEY** money that she made from a commercial sex date through ApplePay.

**COUNT 2: HUMAN TRAFFICKING FOR COMMERCIAL SEX ~ 21 O.S. § 748(A)(6),
a FELONY**

On or about or between June 4, 2026 and June 9, 2026, in Oklahoma County and Caddo

County, the crime of **HUMAN TRAFFICKING FOR COMMERCIAL SEX**, was feloniously committed by **CALEB RICHEY** and **PHALESHA BEAN**, who knowingly recruited, enticed, harbored, maintained, transported, provided and/or obtained another person, to wit: B.M., through deception, force, fraud, threat, and/or coercion for the purpose of engaging B.M. in commercial sex, contrary to the provisions of Section 748(A)(6) of Title 21 and against the peace and dignity of the State of Oklahoma.

**COUNT 3: ACQUIRING PROCEEDS FROM ILLEGAL ACTIVITY, TO WIT:
HUMAN TRAFFICKING FOR COMMERCIAL SEX ~ 21 O.S. § 2001(A), a
FELONY**

On or about or between June 4, 2026, and June 9, 2026, in Oklahoma County and Caddo
County, the crime of **ACQUIRING PROCEEDS FROM ILLEGAL ACTIVITY, TO WIT:
HUMAN TRAFFICKING FOR COMMERCIAL SEX**, was feloniously committed by
CALEB RICHEY and **PHALESHA BEAN**, who knowingly acquired proceeds, knowing those
proceeds were derived from a violation of the Oklahoma Statutes, to wit: Human Trafficking for
Commercial Sex, and knowingly engaged in transactions involving those proceeds, contrary to the
provisions of Section 2001(A) of Title 21 and against the peace and dignity of the State of
Oklahoma.

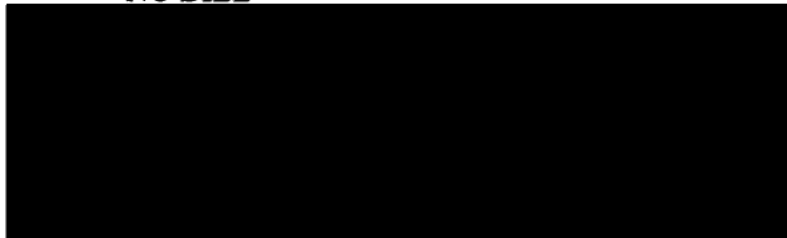

**COUNT 4: POSSESSING CONTRABAND IN A PENAL INSTITUTION, TO WIT: A
CELLPHONE ~ 57 O.S. § 21(E), a FELONY**

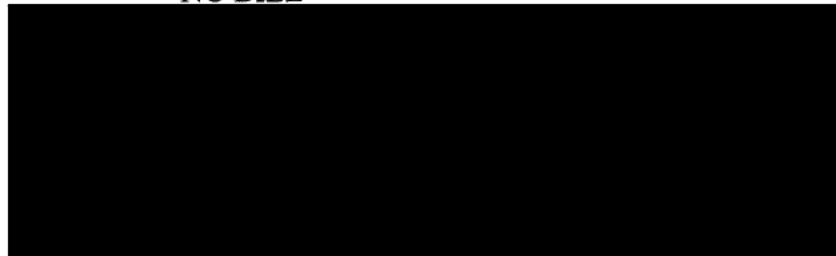
On or about July 22, 2026, in Caddo County, the crime of **POSSESSING
CONTRABAND IN A PENAL INSTITUTION, TO WIT: A CELLPHONE**, was feloniously
committed by **CALEB RICHEY**, who without authority, had possession of a cellphone, an
electronic device, inside Great Plains Correctional Center, located at 700 Sugar Creek Drive,
Hinton, Oklahoma 73047, a penal institution, contrary to the provisions of Section 21(E) of Title
57 and against the peace and dignity of the State of Oklahoma.

COUNT 5: ENGAGING IN A PATTERN OF CRIMINAL OFFENSES ~ 21 O.S. § 425, a FELONY

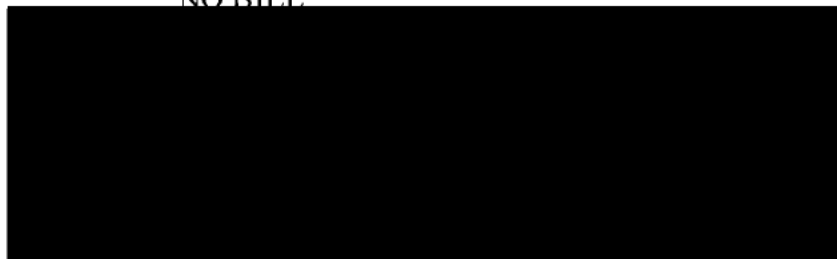
On or about or between June 4, 2026, and June 9, 2026, the crime of **ENGAGING IN A PATTERN OF CRIMINAL OFFENSES** was feloniously committed by **CALEB RICHEY**, **PHALESHA BEAN**, and **LEE SUTTER** by perpetrating criminal offenses – including the crimes of Human Trafficking for Commercial Sex, Acquiring Proceeds from Illegal Activity, and Possessing Contraband in a Penal Institution, to wit: a cellphone – in two or more counties in the State of Oklahoma, with said offenses occurring in Oklahoma County and Caddo County, with such offenses being committed as part of the same plan, scheme, or adventure. Such pattern of offenses included acts which occurred at 700 Sugar Creek Drive, Hinton, Oklahoma 73047; 6209 N. Post Oak Road, Oklahoma City, Oklahoma 73105; and 4525 SW 3rd Street, Oklahoma City, Oklahoma 73108. These acts constituted a pattern of criminal offenses contrary to the provisions of Section 425 of Title 21 of the Oklahoma Statutes and against the peace and dignity of the State of Oklahoma.

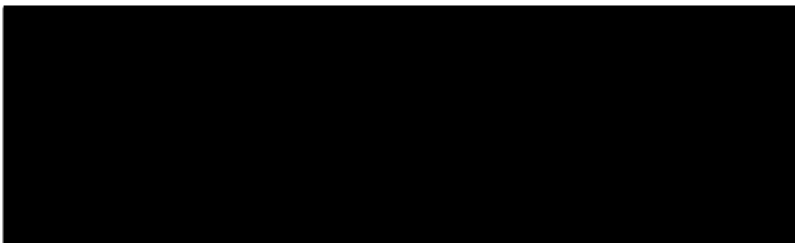
