Next Steps There was no new business.

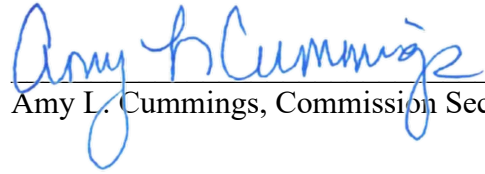
