The notice and agenda for the meeting were publicly posted at the principal office of the Commission at the Will Rogers Memorial Office Building, 2401 North Lincoln Boulevard, Oklahoma City, Oklahoma 73105 at 3:15 p.m., November 17, 2023, by Commission employees acting under the direction of Chairman J. Todd Hiett. The notice and agenda are also made available to the public on the Commission's website, oklahoma.gov/occ. A copy of the notice and agenda is attached to these minutes as Appendix A.

Chairman Hiett called the meeting to order at 1:30 p.m.

Members present were Chairman Todd Hiett, Vice Chairman Kim David, and Commissioner Bob Anthony. A quorum of the Commission was present. Interested persons participated in the meeting in person or by teleconference/videoconference when and as authorized.

- Has everyone so identified acknowledged receipt of their notification, and has anyone indicated they intend to contest all or any part of the CID? Has the Attorney General explicitly excluded anyone from the CID?
- <u>Is the OCC Office of Legal Services providing the same legal advice to everyone expected to produce documents responsive to the CID?</u> If not, how is such advice being differentiated?
- Who outside the Attorney General's Office will have access to what is turned over under this CID?

The Oklahoma Corporation Commission urges and expects the full cooperation of all its officers, personnel and vendors/contractors/payees, as well as all transportation, transmission, oil and gas and utility companies, with any government review, inquiry, audit,

and/or investigation of or involving February 2021's Winter Storm Uri, the costs incurred, recovery of those costs, utility securitization and/or the issuance of ratepayer-backed bonds. Commissioner Hiett announced the agenda item and addressed Commissioner Anthony to lead discussion on his requested item. Pat Franz, agency general counsel, was recognized to address her written response to Commissioner Anthony's inquiries concerning a response to the Attorney General's CID. Ms. Franz provided the referenced response to the Commissioners and the Secretary. Commissioner Anthony MADE A MOTION to adopt the policy statement at the end of agenda item V. Discussion was held. No actions were taken. Commissioner Anthony requested that the minutes reflect that he made the above motion, and stated "what the outcome is has yet to be determined." Chase Snodgrass, deputy attorney general, was recognized to offer a statement on the Attorney General's CID and ongoing communications with OCC staff regarding the CID.

Lauren Willingham, counsel for Public Service Company of Oklahoma, was recognized to present its motion to modify, which included an additional amendment to replace the term "annualized" with "prorated annual basis.". The Commission heard oral arguments from parties on the remaining motions to modify. Discussion was held. Commissioner Anthony MADE A MOTION to grant the motion of the Attorney General to hold harmless and reinstate a 2.5% rate cap. Discussion was held. No actions Teryl Williams, chief advisor and legal counsel, was recognized to advise the Commission on how to proceed. Commissioner Hiett announced that the parties needed a few minutes to incorporate all accepted changes into the proposed order, so all technical conferences on the agenda should proceed., after the conclusion of which the Commission would revisit this agenda item.
