Chairman Hiett called the meeting to order at 1:30 p.m.

Members present were Chairman Todd Hiett, Vice Chairman Kim David, and Commissioner Bob Anthony. A quorum of the Commission was present. Interested persons participated in the meeting in person or by teleconference/videoconference when and as authorized.

<u>Recognition of Employee Service</u> The Commissioners gave recognition to employees for years of service in the employ of the State of Oklahoma.

<u>September 2023 financials and possible discussion of FY 2023, FY 2024 and/or FY 2025</u> <u>budgets – Chief Financial Officer Holly George or Comptroller Jason Harjo</u> Commissioner Hiett announced the agenda item. Chief Financial Officer Holly George provided an update on agency financial activity for the month of September, 2023. Discussion was held.

Briefing on administrative issues, which may include human resources; budget; information technology; OCC building renovation updates; and/or legislative matters, including an update on the Oklahoma State Task Force on Motor Carrier Regulation and Enforcement – Director of Administration Brandy Wreath Commissioner Hiett announced the agenda item and recognized Brandy Wreath, director of administration. Mr. Wreath introduced the Leadership OCC group and briefed the Commission on the group's goals and activities.
