The notice and agenda for the meeting were publicly posted at the principal office of the Commission at the Will Rogers Memorial Office Building, 2401 North Lincoln Boulevard, Oklahoma City, Oklahoma 73105 at 12:00 p.m., November 25, 2024, by Commission employees acting under the direction of Chairman Kim David. Chairman David called the meeting to order at 1:31 p.m.
