The notice and agenda for the meeting were publicly posted at the principal office of the Commission at the Will Rogers Memorial Office Building, 2401 North Lincoln Boulevard, Oklahoma City, Oklahoma 73105 at 9:00 a.m., January 14, 2025, by Commission employees acting under the direction of Chairman Kim David. Notice was provided in writing to the Oklahoma Secretary of State at least forty-eight hours in advance of the meeting, and the notice and agenda are also made available to the public on the Commission's website, oklahoma.gov/occ. Chairman David called the meeting to order at 9:30 a.m.

Members present were Chairman Kim David and Commissioner J. Todd Hiett. Commissioner Brian Bingman was not present. A quorum of the Commission was present. Interested persons participated in the meeting in person or by teleconference/videoconference when and as authorized.

Hearing before an ALJ to supplement the record pursuant to the Joint Motion to Reopen the Record filed November 14, 2024, in Case No. PUD2024-000032, Application of Public Service Company of Oklahoma, and Oklahoma Corporation, for a Proceeding Before the Commission En Banc as Provided for by Order No. 7328226 to Address the Private Letter Ruling Received from the Internal Revenue Service, Commissioner David announced the agenda item and recognized Mark Argenbright, director of the Public Utility Division, to provide an update on her prior request to hire a consultant and/or expert witness. Commissioner David turned the meeting over to administrative law judge ("ALJ") Kenneth Behrens to conduct the hearing. ALJ Behrens took appearances from the parties and proceeded to hear oral arguments and take witness testimony. Discussion was held.
