STATE OF OKLAHOMA: To all persons, owners, producers, operators, purchasers and takers of natural gas in the State of Oklahoma and all other interested parties:

NOTICE IS HEREBY GIVEN that the above-named Applicant has filed an Application requesting that the Commission determine whether the supply of natural gas from the common sources of supply included in and covered by the Red Oak Fanshawe Pool 456, the Red Oak Red Oak Pool 457, the Red Oak Spiro Pool 458, the Guymon Hugoton Pool 182 and the West Cheyenne Upper Morrow Pool 136 is less than the market demand so as to warrant suspension of special field rules calculations for determining allowables for wells in such pools, whether the gas allowables for wells in such pools should be determined as provided in OAC 165:10-17-9 during any such suspension of special field rules calculations, and that an order issue in this cause consistent with such determinations.

SPECIAL RELIEF SOUGHT: That as Order No. 564811 which issued in Cause CD No. 200808626 on January 29, 2009, determining the amount of gas to be produced from the Red Oak Fanshawe Pool 456, the Red Oak Red Oak Pool 457, the Red Oak Spiro Pool 458, the Guymon Hugoton Pool 182 and the West Cheyenne Upper Morrow Pool 136 for the months of February, 2009, through July, 2009, Applicant requests that any order which issues in this cause be made effective as of August 1, 2009.
