

SEMI-ANNUAL SERVICER'S CERTIFICATE

Oklahoma Development Finance Authority Ratepayer-Backed Bonds
(Oklahoma Gas and Electric Company)
Series 2022 (Federally Taxable)

Pursuant to Section 4.01(c)(ii) of the Securitization Property Servicing Agreement, dated as of July 20, 2022, (the “Servicing Agreement”), between OKLAHOMA GAS AND ELECTRIC COMPANY, as Servicer, and OKLAHOMA DEVELOPMENT FINANCE AUTHORITY, the Servicer does hereby certify, for the August 3, 2026 Payment Date (the “Current Payment Date”), as follows:

⁷ Assumes \$67,194.67 will be transferred from the DSRS account to the Collection account. Ending balance will be \$3,808,270.
