RE: Notice of Intent to Construct a Windfarm in Ellis County, Oklahoma

In order to comply with the requirements of Section 17-160.21.A of the Oklahoma Wind Energy Development Act ("Act"), and pursuant to Oklahoma Administrative Code 25:40-3-1(b), within 10 days of a subsequent filing of the Notice of Proposed Construction ("7460-1 Forms") with the Federal Aviation Administration ("FAA"), the owner of a wind energy facility shall submit to the Board of the Ellis County Commission ("County Commission") copies of the subsequent 7460-1 Forms for any individual wind turbines or any other individual structure that requires a 7460-1 Form that is part of a wind energy facility.

This submission is being provided to the County Commission within ten (10) days of the subsequent filing with the FAA of the 7460-1 Forms for additional turbine locations that are a part of the 25 Mile Creek Wind Farm, which is to be located in Ellis County, Oklahoma (the "Project"). Enclosed as Exhibit A are copies of the subsequent 7460-1 Forms submitted to the FAA for the Project as of the date of this submission.

In accordance with Section 17-160.21.A of the Oklahoma Wind Energy Development Act, the Project confirms it is submitting this updated notice to construct to the Oklahoma Corporation Commission ("OCC") and the Oklahoma Aeronautics Commission ("OAC").
