NOTICE OF INTENT TO CONSTRUCT

In order to comply with the requirements of Oklahoma law, codified as The Oklahoma Wind Energy Development Act, specifically Section 160.21 of Oklahoma Statutes Title 17, and as it relates to certain Rules promulgated by the Oklahoma Corporation Commission ("Commission"), NextBra Energy Resources, LLC (the "Company") hereby informs the Commission of its intent to construct the Ponderosa wind energy project (the "Project") located in Beaver County, Oklahoma.

The Project has been under active development for several years. The most recent FAA form 7460-1 filing was made on January 27, 2017. 
